

**CONTRACT ON THE BIDDING FOR THE SUPPLY AND DELIVERY OF BRAND
NEW MOTOR VEHICLES (LOT 3 – LOW FLOOR/LOW ENTRY BUS)
(IB No. SDBNMV 2021-021-BD)**

THIS AGREEMENT made and entered into this APR 20 2022 day of 2022, in the City of QUEZON CITY, Metro Manila, by and between:

PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH), a government owned and controlled corporation duly created by virtue of R.A. 7875, as amended by R.A. 9241 and R.A. No. 10606 or the “National Health Insurance Act of 2013”, with principal office address at 17th Floor, City State Center Building, 709 Shaw Blvd corner Oranbo Drive, Pasig City. PHILHEALTH is represented in this Agreement by its President and Chief Executive Officer (CEO), **ATTY. DANTE A. GIERRAN, CPA** who is authorized to sign this agreement under Corporate Order No. 2018-0026 on the New Delegation and Signing Authority (DSA) in the Head Office and Regional Offices, copy attached hereto as Annex “A”;

GOLDEN ASIA AUTOMOTIVE BUILDERS, INC., a stock corporation, organized and registered with the Securities and Exchange Commission and existing under the laws of the Republic of the Philippines, with business address at #20 Main Moad, Muralla Industrial Park, Perez, Meycauayan, Bulacan, represented herein by its Authorized Representative, **ALFRED JOSEPH S. MANUZON**, (hereinafter called “**GOLDEN ASIA**”), duly authorized for this purpose as evidenced by **GOLDEN ASIA** Secretary’s Certificate, copy attached hereto as Annex “B”.

WHEREAS, PHILHEALTH invited Bids for certain goods and ancillary services particularly the **Supply and Delivery of Brand New Motor Vehicles (Lot 3 – Low Floor/Low Entry Bus)** and has accepted a Bid by **GOLDEN ASIA** for the supply of eight (8) units Low Floor/ Low Entry Bus in the sum of, **FIFTY EIGHT MILLION PESOS (PhP58,000,000.00)** (hereinafter called “**the Contract Price**”),

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz:
 - (a) Corporate Order No. 2018-0026 (**Annex “A”**);
 - (b) **GOLDEN ASIA’s** Secretary’s Certificate (**Annex “B”**);
 - (c) Philippine Bidding Documents (PBDs);
 - (i) **GOLDEN ASIA’s** Schedule of Requirements (**Annex “C”**);
 - (ii) **GOLDEN ASIA’s** Technical Proposal and its Appendices including compliance with the Warranty of Three (3) Years or 200,000 kilometers, whichever comes first, on parts, services and free labor on preventive maintenance services for Low Floor/Low Entry Buses (**Annex “D”**);
 - (iii) General Conditions of the Contract (GCC) (**Annex “E”**);
 - (iv) Special Conditions of the Contract (SCC) (**Annex “F”**);
 - (v) Bid Bulletin No. 01 and 02 (**Annex “G”**);

- (d) **GOLDEN ASIA's Bid**; including the Eligibility requirements, Technical and Financial Proposals, and all other documents/statements submitted; Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarification on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation (**Annex "H"**);
 - (e) Performance Security (**Annex "I"**);
 - (f) Notice of Award Issued on December 31, 2021 (**Annex J"**);
 - (g) BAC-B Resolution No. 39, s. 2021 (**Annex "K"**); and
 - (h) Other contract document that may be required by existing laws and/or **PhilHealth** in the PBDs. **GOLDEN ASIA** agrees that the additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **FIFTY EIGHT MILLION PESOS (PhP58,000,000.00)** or such other sums as may be ascertained, **GOLDEN ASIA** agrees to provide the **Supply and Delivery of Brand New Motor Vehicles (Lot 3 – Low Floor/Low Entry Bus)** and to remedy defects therein within the warranty period in accordance with its Bid.
4. **PHILHEALTH** agrees to pay **GOLDEN ASIA** the above-mentioned sum in accordance with the terms of the Bidding or such other sum as may become payable under the provisions of the Contract at the time and in the manner prescribed under the Contract.


