

**CONTRACT ON THE RE-BIDDING FOR THE
SUPPLY AND DELIVERY OF BRAND NEW MOTOR VEHICLES (LOT 2)
MULTI-PURPOSE VEHICLE

THIS AGREEMENT made and entered into this NOV. 03 day of 2022 2022, in the City of _____, Metro Manila, by and between:

PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH), a government owned and controlled corporation duly organized and existing by virtue of Republic Act No. (RA) 7875, otherwise known as the "National Health Insurance Act", as amended by RA 9241 and RA 10606, with principal office address at 17th Floor, Citystate Centre Bldg., 709 Shaw Blvd. corner Oranbo Drive, Pasig City, represented herein by its Officer-in-Charge, Office of the President and Chief Executive Officer (CEO), **ATTY. ELI DINO D. SANTOS**, duly authorized to enter into this Contract, as evidenced by Secretary's Certificate, which is attached hereto as Annex "A", hereinafter referred to as the "**PHILHEALTH**";


WHEREAS, PHILHEALTH invited Bids for certain goods and ancillary services particularly on the **Procurement of Supply and Delivery of Brand New Motor Vehicles (Lot 2) Multi-Purpose Vehicle** and has accepted the Bid by **CITIMOTORS** for the supply of those goods and services in the sum of, **FORTY-SEVEN MILLION ONE HUNDRED TWENTY-FOUR THOUSAND PESOS (PhP47,124,000.00)** (hereinafter called "**the Contract Price**").


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - (e) Performance Security (**Annex "F"**);

- (f) Notice of Award of Contract and the Bidder's conforme thereto (**Annex "G"**); and
 - (g) Other contract document that may be required by existing laws and/or the **PHILHEALTH** in the PBDs. **CITIMOTORS** agrees that the additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **FORTY-SEVEN MILLION ONE HUNDRED TWENTY-FOUR THOUSAND PESOS (PhP47,124,000.00)** or such other sums as may be ascertained, **CITIMOTORS** agrees to provide the goods and services and to remedy defects therein within the warranty period in accordance with its Bid.
4. **PHILHEALTH** agrees to pay **CT CITIMOTORS, INC.** the above-mentioned sum in accordance with the terms of the Bidding or such other sum as may become payable under the provisions of the Contract at the time and in the manner prescribed under the Contract.


