WHEREAS, PHILHEALTH invited Bids for certain goods and ancillary services particularly on the Procurement of Supply and Delivery of Brand New Motor Vehicles (Lot 2) Multi-Purpose Vehicle and has accepted the Bid by CITIMOTORS for the supply of those goods and services in the sum of, FORTY-SEVEN MILLION ONE HUNDRED TWENTY-FOUR THOUSAND PESOS (PhP47,124,000.00) (hereinafter called "the Contract Price").

In consideration for the sum of **FORTY-SEVEN MILLION ONE HUNDRED TWENTY-FOUR THOUSAND PESOS (PhP47,124,000.00)** or such other sums as may be ascertained, **CITIMOTORS** agrees to provide the goods and services and to remedy defects therein within the warranty period in accordance with its Bid.
- 4. **PHILHEALTH** agrees to pay **CT CITIMOTORS, INC.** the above-mentioned sum in accordance with the terms of the Bidding or such other sum as may become payable under the provisions of the Contract at the time and in the manner prescribed under the Contract.
