- In consideration for the sum of **ONE MILLION TWO HUNDRED FIFTY THOUSAND PESOS (PhP1,250,000.00)** or such other sums as may be ascertained, **BUSYBEE** agrees to provide the goods and services and to remedy defects therein within the warranty period in accordance with its Bid.
- 4. **PHILHEALTH** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
