

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz:
 - (a) **PHILHEALTH's** Secretary's Certificate (**Annex "A"**);
 - (b) **BUSYBEE's** Secretary's Certificate (**Annex "B"**);
 - (c) Philippine Bidding Documents (PBDs);
 - (i) General and Special Conditions of the Contract (**Annex "C"**); and
 - (ii) Bid Bulletin No. 01 (**Annex "D"**);
 - (d) **BUSYBEE's** Bid; including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted (**Annex "E"**);


- (e) Performance Security (**Annex "F"**);
 - (f) Notice of Award of Contract and the Bidder's conforme thereto (**Annex "G"**); and
 - (g) Other contract document that may be required by existing laws and/or the **PHILHEALTH** in the PBDs. **BUSYBEE** agrees that the additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **ONE MILLION TWO HUNDRED FIFTY THOUSAND PESOS (PhP1,250,000.00)** or such other sums as may be ascertained, **BUSYBEE** agrees to provide the goods and services and to remedy defects therein within the warranty period in accordance with its Bid.
4. **PHILHEALTH** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.






