

CONTRACT OF SERVICES
Mandatory Drug Testing for PRO IVA Employees

The **PHILIPPINE HEALTH INSURANCE CORPORATION REGIONAL OFFICE IVA**, a government owned and controlled corporation duly organized and existing by virtue of Republic Act No. 7875, as amended, with Regional Office at Lucena Grand Central Terminal, Brgy. Ilayang Dupay Lucena City, represented herein by its Regional Vice President **DANILO M. REYNES, MD, MPA**, who is authorized for this purpose through Corporate Order No. 2018-0026 New Delegation and Signing Authority (DSA), a copy of which is attached as **Annex "A"**, hereinafter referred as the **"FIRST PARTY"**

-and-

LC DIAGNOSTIC CENTER, a sole proprietorship duly registered with Department of Trade and Industry (DTI) and existing under the laws of the Republic of the Philippines with business address at Diversion Road, Domoit, Lucena City, represented herein by its Proprietor, **ELSIE LIM TAN** hereinafter referred as the **"SECOND PARTY"**

WITNESSETH

That the **FIRST PARTY** and **SECOND PARTY** in consideration of the mutual covenants and agreement made herein, by one to the other, by these presents enter into a Contract Agreement whereby the **FIRST PARTY** secure the services of the **SECOND PARTY** wherein the latter will undertake to perform such services on the following terms and conditions:

1. In this Agreement, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract referred to.
2. The Supplier's Bid or filled-out Request for Quotation shall form and be read and construed as part of this Agreement and attached hereto as **Annex "B"**.
3. In consideration of the payments to be made by **FIRST PARTY** to **SECOND PARTY** as hereinafter mentioned, **SECOND PARTY** hereby covenants with **FIRST PARTY** to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. **FIRST PARTY** hereby covenants to pay **SECOND PARTY** in consideration of the provision of the goods and services and the remedying of defects therein the Contract Price in the manner prescribed by the contract.
5. The contract price covers the costs of all Deliverables Items and Services and includes all applicable taxes, including the 12% Value-Added-Tax, customs duties, license fees, freight, insurance, cost of importation, transportation and delivery at the time and locations specified and other charges which may be imposed on the Product by foreign and local authorities.
6. **SECOND PARTY** hereby covenants to deliver in favor of **FIRST PARTY** the **Mandatory Drug Testing for PRO IVA Employees** and the services related hereto, in accordance with the technical specifications as stated in **Annex "C"** of this contract.
7. This contract agreement shall be payable in the total amount of **Sixty Two Thousand Two Hundred Twenty Pesos (Php 62,220.00)**. The **FIRST PARTY** shall pay **SECOND PARTY** for each service rendered and accepted by **FIRST PARTY** within fifteen (15) working days upon submission of **SECOND PARTY** of the **STATEMENT OF BILLING ACCOUNT** and other documentary requirements as may be required by **FIRST PARTY** as condition for payment, provided that the same has been verified to be correct by **FIRST PARTY** Contract duration starts within one (1) day from receipt of signed Contract by **SECOND PARTY** and ends by December 31, 2022 or upon consumption of contract amount whichever may come first.
8. Both parties hereby warrant that they have the authority and capacity to enter and sign in this contract.
9. All other terms, conditions and stipulations accompanying this Contract together with all proposals and all mandatory provisions of the 2016 Revised Implementing Rules and Regulations of R.A. No. 9184, shall form as integral parts of this contract between the **PARTIES** hereto.




