

**CONTRACT OF SERVICES**  
**Radio Blocktime**

The **PHILIPPINE HEALTH INSURANCE CORPORATION REGIONAL OFFICE IVA**, a government owned and controlled corporation duly organizes and existing by virtue of Republic Act No. 7875, as amended, with Regional Office at Lucena Grand Central Terminal, Brgy. Ilayang Dupay Lucena City, represented herein by its Regional Vice President **DANILO M. REYNES, MD, MPA**, who is authorized for this purpose through Corporate Order No. 2018-0026 New Delegation and Signing Authority (DSA), hereinafter referred as the **“FIRST PARTY”**

-and-

**95.1 KISS FM Southern Luzon**, owned and managed by **KATIGBAK ENTERPRISES (SAN PABLO CITY) INCORPORATED**, a corporation registered under the Securities and Exchange Commission and existing under the laws of the Republic of the Philippines with business address at 1022 DCG Tower One Maharlika Highway, Brgy. Isabang, Tayabas City, represented herein by its Administrative Officer, **RAMIL A. RAMOS**, hereinafter referred as the **“SECOND PARTY”**

**WITNESSETH**


That the **FIRST PARTY** and **SECOND PARTY** in consideration of the mutual covenants and agreement made herein, by one to the other, by these presents enter into a Contract Agreement whereby the **FIRST PARTY** secure the services of the **SECOND PARTY** wherein the latter will undertake to perform such services on the following terms and conditions:

1. In this Agreement, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract referred to.
2. The Supplier’s Bid or filled-out Request for Quotation shall form and be read and construed as part of this Agreement and hereby agrees to provide radio blocktime for one (1) hour per episode or total of twenty (20) hours to **SECOND PARTY**.
3. In consideration of the payments to be made by the **FIRST PARTY** to the **SECOND PARTY** as hereinafter mentioned, the **SECOND PARTY** hereby covenants with the **FIRST PARTY** to provide the radio blocktime and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The **FIRST PARTY** hereby covenants to pay the **SECOND PARTY** in consideration of the provision of the services and the remedying of defects therein the Contract Price in the manner prescribed by the contract.
5. The contract price covers the costs of all Deliverables Items and Services and includes all applicable taxes, customs duties, license fees, freight, insurance, cost of importation, transportation and delivery at the time and locations specified and other charges which may be imposed on the Product by foreign and local authorities.
6. The **SECOND PARTY** hereby covenants to provide radio blocktime in favor of the **FIRST PARTY** in accordance to the technical specifications as stated in Annex **“A”** of this contract.

7. This contract agreement shall be payable in the total amount of **Two Hundred Forty Thousand Pesos (Php 240,000.00)**. The **FIRST PARTY** shall pay the **SECOND PARTY** upon submission of the **SECOND PARTY** of the **STATEMENT OF BILLING ACCOUNT** and other documentary requirements as may be required by the **FIRST PARTY** as condition for payment provided that the same has been verified to be correct by the **FIRST PARTY**. The payment schedule shall be as follows:

8. Contract duration starts from receipt of Contract by the **SECOND PARTY** and ends on December 31, 2022.
9. The **SECOND PARTY** shall comply with EO 398 and submit its income and business tax returns duly stamped and received by the Bureau of Internal Revenue, before entering and during the duration of the Contract. It shall pay taxes in full and on time and that the failure to do so will entitle the **FIRST PARTY** to suspend payment for any services delivered by **SECOND PARTY**.
10. Both **PARTIES** hereby warrant that they have the authority and capacity to enter and sign in this contract.
11. All other terms, conditions and stipulations accompanying this Contract together with all proposals and all mandatory provisions of the 2016 Revised Implementing Rules, Regulations of R.A. No. 9184 and other applicable GPPB issuance between shall form an integral part of this contract between the **PARTIES** hereto.
