

CONTRACT AGREEMENT

Lease of Venue and Meals for the Conduct of BAS Corporate Forum for CY 2022

PHILIPPINE HEALTH INSURANCE CORPORATION REGIONAL OFFICE IV A (PRO IVA), a government owned and controlled corporation duly organized and existing by virtue of Republic Act No. 7875, as amended, with office address at Regional Office at Lucena Grand Central Terminal, Brgy. Ilayang Dupay Lucena City, represented herein by its Regional Vice President **DANILO M. REYNES, MD, MPA**, who is authorized for this purpose through Corporate Order No. 2018-0026 New Delegation and Signing Authority (DSA), a copy of which is attached as **Annex A**;

ST. JUDE MULTI-PURPOSE COOPERATIVE (SJMPCC), a domestic corporation duly organized and existing under the laws of Republic of the Philippines and registered with the Securities and Exchange Commission, with office address at Diversion Road, Brgy. Isabang, Lucena City, represented herein by its General Manager, **MELANIE FONTARUM**.

WITNESSETH

The **PRO IVA** and **SJMPCC** agree in this Agreement the following terms and conditions for PRO IV-A's lease of venue for the conduct of Benefits Administration Section (BAS) Corporate Forum for 2022, as follows:

- 1. In this Agreement, words and expressions shall have the same meaning as are assigned to them in the Request for Quotation and Technical Specifications, which are respectively attached as **Annex B and C**.
- 2. The Supplier's Bid or filled-out Request for Quotation shall form and be read and construed as part of this Agreement and attached hereto as **Annex D** and hereby agrees to deliver:

- 3. The total consideration payable to SJMPCC under this Contract is P 49,200.00 which includes all applicable taxes, duties, fees and other cost.

PRO IV-A shall pay the SJMPCC after rendition of service/ provision of lease, remediation of defects, if any, and provided that a PRO IV-A issued a certificate of acceptance and other documentary requirements as may be required to effect payment.

4. **PRO IVA** and **SJMPC** hereby warrant that they have the authority and capacity to enter and sign in this contract.
5. All other terms, conditions and stipulations accompanying this Contract together with all proposals and all mandatory provisions of the 2016 Revised Implementing Rules and Regulations of R.A. No. 9184, shall form as integral parts of this contract between **PRO IVA** and **SJMPC** hereto.
6. Any dispute, claim, or controversy that may arise from or in relation to this Contract, involving but not limited to demands for the specific performance of the obligations as specified herein and/or in the interpretation of any provisions or clauses contained herein, shall, in the first instance, be settled through amicable means.

In case of failure to settle amicably the dispute upon the lapse of thirty (30) days from either party's request for good faith negotiations or discussions with a view to amicably settling the dispute (or upon the lapse of such extended period as the parties may agree in writing) shall be submitted to arbitration in accordance with Republic Act 9285 (Alternative Dispute Resolution Act of 2004).

Any legal action necessary to promote arbitration or ancillary to such arbitration shall be instituted in the proper courts in Lucena City to the exclusion of other courts of equal jurisdiction.


