

CONTRACT OF SERVICES

Training on Risk Management: Assessment, Identification and Prioritization

KNOW ALL MEN BY THESE PRESENTS:

PHILIPPINE HEALTH INSURANCE CORPORATION REGIONAL OFFICE IV-A, a government owned and controlled corporation created and existing by virtue of R.A. 7875, as amended, with Regional Office address at Lucena Grand Central Terminal, Diversion Road, Brgy. Ilayang Dupay, Lucena City, represented herein by its Regional Vice-President, **DANILO M. REYNES, MD, MPA**, hereinafter referred to as "FIRST PARTY"

and

TRUST MANAGEMENT CENTRE, sole proprietorship, organized and existing under Philippine Laws, with office address at Blk 4 Unit 14-05, 14 Floor Camella Northpoint, JP Laurel Avenue, Bahaça, Davao City, Davao Del Sur, duly represented herein by **KISHORELAL J. MULCHANDANI**, and hereinafter referred to as the "SECOND PARTY";

The FIRST PARTY and SECOND PARTY shall be individually referred to as "Party" and collectively referred to as "Parties".

WITNESSETH:

That the FIRST PARTY and SECOND PARTY, agree in this Contract to the following terms and conditions for the latter's rendition of training on Risk Management: Assessment, Identification and Prioritization:

1. In this Contract, words and expressions shall have the same meaning as assigned to them in the Technical Specifications (TS) which is attached as Annex A.
2. The SECOND PARTY agrees to deliver to FIRST PARTY the training requirements as provided under the TS. SECOND PARTY submitted bid or filled-out Request for Quotation shall form part of this Contract:

In consideration of the payments to be made by the FIRST PARTY to the SECOND PARTY as hereinafter mentioned, the SECOND PARTY hereby covenants with the FIRST PARTY to provide the training and its inclusions and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The FIRST PARTY hereby covenants to pay the SECOND PARTY in consideration of the provision of the services and the remedying of defects therein the Contract Price in the manner prescribed by the contract.

5. The contract price covers the costs of all Deliverables Items and Services and includes all applicable taxes, including the 12% Value-Added-Tax, customs duties, license fees, freight, insurance, cost of importation, transportation and delivery at the time and locations specified and other charges which may be imposed on the Product by foreign and local authorities.
6. The SECOND PARTY hereby covenants to deliver in favor of the FIRST PARTY the Training on Risk Management: Assessment, Identification and Prioritization in accordance with the technical specifications of this contract.
7. The total consideration payable to the SECOND PARTY under this Contract is PhP 70,000.00 which includes all applicable taxes, duties, fees and other cost.



9. All other terms, conditions and stipulations accompanying this Contract together with all proposals and all mandatory provisions of the 2016 Revised Implementing Rules and Regulations of R.A. No. 9184, shall form as integral parts of this contract between the PARTIES hereto.
10. The PARTIES hereby certify that they have read or caused to be read to them each and every provision of this Contract and that they have fully understood the same.


