

CONTRACT AGREEMENT

Procurement of Periodic Health Examination of PhilHealth Regional office IVA
(PRO IVA) Employees for CY 2023

This contract is entered on JUL 14 2023 between:

PHILIPPINE HEALTH INSURANCE CORPORATION REGIONAL OFFICE IV A (PRO IVA), a government owned and controlled corporation duly organized and existing by virtue of Republic Act No. 7875, as amended, with office address at Regional Office at Lucena Grand Central Terminal, Brgy. Ilayang Dupay Lucena City, represented herein by its Regional Vice President **DANILO M. REYNES, MD, MPA**, who is authorized for this purpose through Corporate Order No. 2018-0026 New Delegation and Signing Authority (DSA), a copy of which is attached as Annex "A", hereinafter referred to as the **"First Party"**

LUCENA UNITED DOCTORS INCORPORATED, a corporation duly registered with the Securities and Exchange Commission (SEC) and existing under the laws of the Republic of the Philippines with business address at Brgy., Isabang, Lucena City, represented herein by its Marketing Manager, **RONALD ANTHONY C. ORLANDO**, hereinafter referred to as the **"Second Party"**

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the **Procurement of Periodic Health Examination of PhilHealth Regional office IVA (PRO IVA) Employees for CY 2023** and has accepted a Bid by the Supplier for the supply of those goods and services in the amount of **Two Million Nine Hundred Twenty-Two Thousand Eight Hundred Sixty Pesos (₱2,922,860.00)**, hereinafter called **"the Contract Price"**

The **FIRST PARTY** and **SECOND PARTY** shall be individually referred to as "Party" and collectively referred to as "Parties".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:

- i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

In consideration for the sum of **Two Million Nine Hundred Twenty-Two Thousand Eight Hundred Sixty Pesos (P2,922,860.00)**, or such other sums as may be ascertained, **Second Party** agrees to deliver the requirements for the **Procurement of Periodic Health Examination of PhilHealth Regional office IVA (PRO IVA) Employees for CY 2023** in accordance with his/her/its Bid.
4. The **Philippine Health Insurance Corporation** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
