PHILIPPINE HEALTH INSURANCE CORPORATION REGIONAL OFFICE IV A (PRO IVA), a government owned and controlled corporation duly organized and existing by virtue of Republic Act No. 7875, as amended, with office address at Regional Office at Lucena Grand Central Terminal, Brgy. Ilayang Dupay Lucena City, represented herein by its Regional Vice President **DANILO M. REYNES, MD, MPA**, who is authorized for this purpose through Corporate Order No. 2018-0026 New Delegation and Signing Authority (DSA), a copy of which is attached as Annex "A", hereinafter referred to as the **"FIRST PARTY"**

-and-

MYBUSYBEE, INC a corporation duly registered with the Securities and Exchange Commission (SEC) and existing under the laws of the Republic of the Philippines with business address at Unit 7 G/F Burgundy Place Condominium 174-B Gonzales St. Loyola Heights Quezon City, represented herein by its Chief Executive Officer, **RICO M. HERNANDEZ**, hereinafter referred to as the **"SECOND PARTY"**

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the **Procurement of SMS Bulk Messaging** and has accepted a Bid by the Supplier for the supply of those goods and services in the amount of **Six Hundred Twenty Two Thousand Two Hundred Twenty One and 60/100 pesos (PhP 622,221.60)**, hereinafter called **"the Contract Price"**

The **FIRST PARTY** and **SECOND PARTY** shall be individually referred to as "Party" and collectively referred to as "Parties".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:

 - iii. General and Special Conditions of Contract

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
