

**“BAC RESOLUTION DECLARING SINGLE CALCULATED AND
RESPONSIVE BID (SCRB) AND RECOMMENDING APPROVAL FOR
THE PROCUREMENT OF ONE (1) LOT I.T SUPPLIES WITH FREE
OF PRINTERS FOR PHILHEALTH REGIONAL OFFICE XI C.Y 2023”
RESOLUTION NUMBER 2023-026

WHEREAS, Philhealth Regional Office XI Bids and Awards Committee (BAC) advertised the Invitation to Apply for Eligibility and to Bid for the **PROCUREMENT OF ONE (1) LOT I.T SUPPLIES WITH FREE OF PRINTERS FOR PHILHEALTH REGIONAL OFFICE XI C.Y 2023** and posted the same in the Philhealth website, the PhilGEPS and the conspicuous place of Philhealth Regional Office XI;

WHEREAS, in response to the said advertisements, **NEED INK SALES & SERVICES** submitted to the BAC its letter of intent and application for eligibility;

WHEREAS, the opening of bid/s was held last **MAY 9, 2023** at the Conference Room, Valgosons Building office of Philhealth Regional Office XI, **NEED INK SALES & SERVICES** participated as the as eligible bidder;

WHEREAS, during the opening of bids held last **MAY 9, 2023** at the Conference Room, Valgosons Building office of Philhealth Regional Office XI, **NEED INK SALES & SERVICES**, it was determined to be the **SINGLE CALCULATED BIDDER (SCB)** by the **COMMITTEE**;

WHEREAS, the bid proposal of **NEED INK SALES & SERVICES** was found to be compliant, such that:

Approved Budget for the Contract (ABC) – **ONE MILLION ONE HUNDRED SIXTY THOUSAND SEVEN HUNDRED PESOS & 00/100 (P 1,160,700.00)** only;

BID AMOUNT (AS READ) – **ONE MILLION ONE HUNDRED FIFTY SEVEN THOUSAND TWO HUNDRED EIGHTY PESOS & 00/100 (P 1,157,800.00)** only;

WHEREAS, upon closer and careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the eligible bidder/s, **NEED INK SALES & SERVICES**, their bid/s have been found to be responsive for the **PROCUREMENT OF ONE (1) LOT I.T SUPPLIES WITH FREE OF PRINTERS FOR PHILHEALTH REGIONAL OFFICE XI C.Y 2023**;

WHEREAS, Section 34.3 of the Revised Implementing Rules and Regulations of Republic Act 9184 provides that the Post qualification shall verify, validate and ascertain all statements made and documents submitted by the bidders with the Lowest Calculated Bid/Highest Rated Bid, using Non-discretionary Pass/Fail criteria, as stated in the Bidding Documents;

WHEREAS, upon Post Qualification Evaluation conducted by the BAC Technical Working Group (BAC-TWG) on the **PROCUREMENT OF ONE (1) LOT I.T SUPPLIES WITH FREE OF PRINTERS FOR PHILHEALTH REGIONAL OFFICE XI C.Y 2023**, per BAC-TWG REPORT OF EVALUATION NUMBER **23-05-01** dated **MAY 26, 2023**, which Report of Evaluation was received by the BAC on **MAY 26, 2023**, the Eligibility documents submitted, as well as the Technical and Financial Proposal of **NEED INK SALES & SERVICES** is in order, valid and conforms to the requirements of bidding for the **PROCUREMENT OF ONE (1) LOT I.T SUPPLIES WITH FREE OF PRINTERS FOR PHILHEALTH REGIONAL OFFICE XI C.Y 2023**;

WHEREAS, on the same **TECHNICAL WORKING GROUP (BAC-TWG) REPORT OF EVALUATION** it was mention that upon further and thorough validation by the BAC-TWG, it was found out that the bidder was declared **responsive** and to recommend for the issuance of **NOTICE OF AWARD**;

WHEREAS, on **JUNE 5, 2023**, the BAC members deliberated and resolved the findings in favor of its approval;

WHEREAS, the **COMMITTEE** further agreed that the **PROCUREMENT OF ONE (1) LOT I.T SUPPLIES WITH FREE OF PRINTERS FOR PHILHEALTH REGIONAL OFFICE XI C.Y 2023** and the procurement proceedings are in compliance with the procurement law;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- b) To recommend for the approval of the Regional Vice President of Philhealth Regional Office XI the foregoing findings.

RESOLVE FURTHER, this is also to support for the approval of **NOTICE OF AWARD, NOTICE TO PROCEED** and the **PROCUREMENT CONTRACT** for the **PROCUREMENT OF ONE (1) LOT I.T SUPPLIES WITH FREE OF PRINTERS FOR PHILHEALTH REGIONAL OFFICE XI C.Y 2023**.


