  - (d) **LEE DESIGNS**'s Bid; including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted **(Annex "G")**;

The Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to

request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- In consideration for the sum of Three Million Six Hundred Two Thousand 3. Six Hundred Thirty-Eight Pesos (\$\frac{1}{2}\$,602,638.00) or such other sums as may be ascertained, LEE DESIGNS agrees to provide the Procurement of One (1) Lot Various Office Chairs and to remedy defects therein within the warranty period in accordance with its Bid.
- PHILHEALTH agrees to pay LEE DESIGNS the above-mentioned sum in 4. accordance with the terms of the Bidding.
