LEDESMA, JR., duly authorized to enter into this Contract, as evidenced by Secretary's Certificate, which is attached hereto as Annex "A", hereinafter referred to as the "PHILHEALTH";

VILLARIN, who is granted full power and authority to sign this agreement under Secretary's Certificate dated May 27, 2024 attached hereto as Annex "B", hereinafter referred to as the "RED ROOT".

 - (d) **RED ROOT**'s Bid; including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted (Annex "G");

The Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- (g) Other contract documents that may be required by existing laws and/or the **PHILHEALTH** in the PBDs. **RED ROOT** agrees that the additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. **RED ROOT** shall coordinate closely with **PHILHEALTH** for the photo research, photo-sourcing, and selection of photos for the contracted Coffee Table Book;
- 4. In consideration for the sum of **Two Million One Hundred Forty-Nine Thousand Pesos**, (\$\mathbb{P}2,149,000.00)\$ or such other sums as may be ascertained, **RED ROOT** agrees to provide and deliver the goods and services for the **Procurement of Coffee Table Book** and to remedy defects therein within the warranty period in accordance with its Bid.
- 5. **PHILHEALTH** agrees to pay **RED ROOT** the above-mentioned sum in accordance with the terms of the Bidding.
