## BIDS & AWARDS COMMITTEE (BAC) - GOODS AND SERVICES A (BAC-GS A) RESOLUTION NO. 90 s. 2024

RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF THE CONTRACT FOR THE PROCUREMENT OF COFFEE TABLE BOOK WITH INVITATION TO BID NO. BOOK 2024-06-GSA TO RED ROOT ARTISTS AND ARTISANS MULTI-PURPOSE COOPERATIVE AS THE BIDDER WITH THE LOWEST CALCULATED RESPONSIVE BID (LCRB)

WHEREAS, based on the approved Purchase Request (PR) No. 23-0007-PB, the Corporate Communication Department requested for the Procurement of Coffee Table Book with an Approved Budget for the Contract (ABC) of Three Million Three Hundred Thousand Pesos (₱3,300,000.00) which is included in the 4th Batch Annual Procurement Plan (APP) CY 2024;

WHEREAS, on 10 May 2024, the Bidding Documents and the Invitation to Bid (IB) No. BOOK 2024-06-GSA for the subject procurement were posted at the Philippine Government Electronic Procurement System (PhilGEPS) and conspicuous places located in the PhilHealth Head Office in compliance with Section 21 of the 2016 Revised IRR of Republic Act No. 9184;

WHEREAS, in response to the posted procurement opportunity, two (2) prospective bidders obtained the bidding documents, namely:

- 1. VJ Graphic Arts, Inc.; and
- 2. Red Root Artists and Artisans Multi-Purpose Cooperative;

WHEREAS, on 17 May 2024, the Pre-Bid Conference for the subject procurement was conducted to address the inquiries and clarifications raised by the prospective bidders. Accordingly, the Bid Bulletin No. 01 was issued on 22 May 2024;

WHEREAS, the two (2) prospective bidders timely submitted their respective bids before the opening of bids held on 29 May 2024;

WHEREAS, in the Opening of Bids and Bid Evaluation which was conducted on the same date, the Red Root Artists and Artisans Multi-Purpose Cooperative was declared as the bidder with the Lowest Calculated Bid (LCB) with a financial bid of Two Million One Hundred Forty-Nine Thousand Pesos (\$\frac{P}{2}\$,149,000.00). Subsequently, the Red Root Artists and Artisans Multi-Purpose Cooperative was subjected for post-qualification;

WHEREAS, the Technical Working Group (TWG)-GS A conducted the post-qualification on 5 June 2024 and presented its post-qualification report thru its Chairperson, Atty. Chelo Anne V. Cruz-Deocampo, during the BAC-GS A meeting on 11 June 2024. The TWG-GS A stated that after verification and evaluation of the eligibility, technical, financial and additional post-qualification requirements submitted by Red Root Artists and Artisans Multi-Purpose Cooperative, it was found to be "responsive" with the requirements for the bidding of the subject procurement;

WHEREAS, the BAC-GS A concurred with the recommendation of the TWG-GS A to declare Red Root Artists and Artisans Multi-Purpose Cooperative as the bidder with the Lowest Calculated Responsive Bid (LCRB);





PREMISES CONSIDERED, the BAC-GS A resolves, as it is hereby resolved, to recommend to the President and CEO, as the Head of the Procuring Entity, the award of the contract for the Procurement of Coffee Table Book under IB No. BOOK 2023-06-GSA to the RED ROOT ARTISTS AND ARTISANS MULTI-PURPOSE COOPERATIVE as the bidder with the Lowest Calculated Responsive Bid.
