BIDS & AWARDS COMMITTEE (BAC) – GOODS AND SERVICES (GS) B RESOLUTION NO. <u>179</u> s. 2024

RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF THE CONTRACT ON THE BIDDING FOR THE PROCUREMENT OF SUPPLY, DELIVERY AND TAILORING SERVICES OF CY 2024 PHILHEALTH CORPORATE UNIFORM WITH INVITATION TO BID NO. UNIFORM 2024-16-GSB TO THE CKDIAZ GENERAL MERCHANDISE AS THE BIDDER WITH THE LOWEST CALCULATED RESPONSIVE BID

WHEREAS, based on the approved Purchase Request (PR) No. 24-0020-PB, the Philhealth Uniform Committee through the Human Resource Department (HRD) requested for the Procurement of Supply, Delivery and Tailoring Services of CY 2024 PhilHealth Corporate Uniform through Competitive Bidding with a total Approved Budget for the Contract (ABC) of Twenty-Eight Million Eight Hundred Forty Thousand Five Hundred Pesos (₱28,840,500.00) which is included in the 10th Batch of Supplemental Annual Procurement Plan (APP) for CY 2024;

WHEREAS, on 25 June 2024, the Bidding Documents and the Invitation to Bid (IB) No. UNIFORM 2024-16-GSB for the subject procurement were posted at the Philippine Government Electronic Procurement System (PhilGEPS), PhilHealth website and conspicuous places located in the PhilHealth Head Office in compliance with Section 21 of the 2016 Revised IRR of Republic Act No. 9184 with the following details:

WHEREAS, on 03 July 2024, the Pre-Bid Conference for the subject procurement was conducted to address the inquiries and clarifications to be raised by the prospective bidders. Accordingly, the Bid Bulletin No. 01 was issued on 09 July 2024;

WHEREAS, on 09 July 2024, a Notice for the Change of Schedule in the submission and Opening of Bids was issued, and that instead of 15 July 2024 the Submission and Opening of Bids was moved to 17 July 2024;

WHEREAS, in response to the posted procurement opportunity, the following two (2) bidders have obtained the bidding documents:

- 1. Risla Collection Inc.; and
- 2. CKDiaz General Merchandise

WHEREAS, Risla Collection Inc. and CKDiaz General Merchandise have timely submitted their respective bids prior to the deadline of submission and opening of bids on 17 July 2024;

WHEREAS, during the Opening of Bids and Bid Evaluation which was conducted on the same date, the CkDiaz General Merchandise was declared as the bidder with the Lowest Calculated Bid (LCB) of Twenty-Three Million Eight Hundred Thirty-Five Thousand Eight Hundred Forty-Eight Pesos (\$\mathbb{P}23,835,848.00)\$ which has a variance of Two Thousand Pesos (\$\mathbb{P}2,000.00)\$ from its offer amounting to of Twenty-Three Million Eight Hundred Thirty-Seven Thousand Eight Hundred

Forty-Eight Pesos (\$\mathbb{P}23,837,848.00)\$. Subsequently, CKDiaz General Merchandise was subjected to post-qualification process within Twelve (12) calendar days or until 29 July 2024;

WHEREAS, during the Bids and Awards Committees (BAC)-Goods and Services (GS) B meeting on 30 July 2024, the Secretariat for the Bids and Awards Committees (SBAC) presented the letter-request dated 26 July 2024 from the TWG-GS B requesting an extension for the conduct of the post-qualification and submission of its post-qualification report due to prior scheduled activities or from July 29, 2024 to August 7, 2024. Thus, the BAC-GS B granted the said request to give ample time for the TWG to evaluate the bid proposal of the bidder with the Lowest Calculated Bid and to finalize its post-qualification report;

WHEREAS, the Technical Working Group (TWG)-Goods and Services (GS) B conducted the post-qualification on 06 August 2024 and presented its post-qualification report thru its Chairperson, Atty. Susan G. Iduyan, during the BAC-GS B meeting on 19 August 2024. The TWG-GS B stated that after verification and evaluation of the eligibility, technical, financial and additional post-qualification requirements submitted by the CKDiaz General Merchandise, they were found to be "responsive" with the requirements. Also, the TWG -GS B manifested that CKDiaz General Merchandise has accepted the calculated bid amounting to Twenty-Three Million Eight Hundred Thirty-Five Thousand Eight Hundred Forty-Eight Pesos (\$\mathbb{P}23,835,848.00)\$ which is within the ABC on the bidding for the subject procurement and recommended that the same bidder be declared as "POST-QUALIFIED";

WHEREAS, the BAC-GS B concurred with the recommendation of the TWG-GS B to declare CKDiaz General Merchandise as the bidder with the Lowest Calculated Responsive Bid (LCRB);

PREMISES CONSIDERED, the BAC-GS B RESOLVES, as it is hereby resolved, to recommend to the President and CEO, as the Head of the Procuring Entity, the award of the contract on the bidding for the procurement of Supply, Delivery and Tailoring Services of CY 2024 PhilHealth Corporate Uniform with Invitation to Bid No. UNIFORM 2024-16-GSB to CKDIAZ GENERAL MERCHANDISE as the bidder with the Lowest Calculated Responsive Bid.
