## CONTRACT ON THE BIDDING FOR THE PROCUREMENT OF FLASK/TUMBLER FOR PHILHEALTH **EMPLOYEES**

[IB No. FLASK 2024-10-GSA]

THIS AGREEMENT made and entered into this 2024, in the City of CONTOCAN CITY, Metro Manila, by and between:

PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH), a government-owned and controlled corporation duly organized and existing by virtue of Republic Act No. (RA) 7875, otherwise known as the "National Health Insurance Act", as amended by RA 9241 and RA 10606, with principal office address at 17th Floor, Citystate Centre Bldg., 709 Shaw Blvd. corner Oranbo Drive, Pasig City, represented herein by its President and Chief Executive Officer (PCEO), EMMANUEL R. LEDESMA, JR., duly authorized to enter into this Contract, as evidenced by Secretary's Certificate, which is attached hereto as Annex "A", hereinafter referred to as the "PHILHEALTH";

## -and-

MITSUI TRADING PHILS. LTD. CO., a partnership duly organized and existing under and by virtue of the law of the Republic of the Philippines, with office address at #100 A. Del Mundo St. between 7th & 8th Avenue, Grace Park, Caloocan City, represented herein by its Business Development Officer, EMILY B. COLLADO who is granted full power and authority to sign this agreement under Secretary's Certificate dated June 18, 2024, attached hereto as Annex "B", herein after referred to as the "MITSUI".

WHEREAS, PHILHEALTH invited Bids for certain goods particularly on the Procurement of Flask/Tumbler for PhilHealth Employees and has accepted the bid by MITSUI, for the supply of those goods in the sum of Two Million Five Hundred Thirty-Seven Thousand Five Hundred Twenty-Nine Pesos and Twelve Centavos (P2,537,529.12) (hereinafter called "the Contract Price").

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are 1. respectively assigned to them in the Conditions of Contract referred to.

    - Bid Bulletin No. 01 (Annex "F");
  - (d) MITSUI's Bid; including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted (Annex "G");

The Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including

corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- (e) Performance Security (Annex "H");
- (f) Notice of Award of Contract and the Bidder's conforme thereto (Annex "I"); and,
- (g) Other contract documents that may be required by existing laws and/or the **PHILHEALTH** in the PBDs. **MITSUI** agrees that the additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of Two Million Five Hundred Thirty-Seven Thousand Five Hundred Twenty-Nine Pesos and Twelve Centavos (P2,537,529.12) or such other sums as may be ascertained, Mitsui agrees to provide the Procurement of Flask/Tumbler for PhilHealth Employees and services and to remedy defects therein within the warranty period in accordance with its Bid.
- 4. **PHILHEALTH** agrees to pay **MITSUI** the above-mentioned sum in accordance with the terms of the Bidding.
