BIDS & AWARDS COMMITTEE (BAC) – GOODS AND SERVICES A (GS A) RESOLUTION NO. 42 s. 2024

RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF THE CONTRACT ON THE BIDDING FOR THE PROCUREMENT OF FLASK/TUMBLER FOR PHILHEALTH EMPLOYEES WITH INVITATION TO BID NO. FLASK 2024-10-GSA TO MITSUI TRADING PHILS., LTD. CO. AS THE BIDDER WITH THE LOWEST CALCULATED RESPONSIVE BID

WHEREAS, based on the approved Purchase Request (PR) No. 24-0013-PB, the Corporate Affairs Group (CAG) requested for the Procurement of Flask/Tumbler for PhilHealth Employees through Competitive Bidding with the Approved Budget for the Contract (ABC) of Four Million Three Hundred Sixty-Seven Thousand Five Hundred Twenty Pesos (\$\Pm\$4,367,520.00) which is included in the 4th Batch of CY 2024 Annual Procurement Plan (APP);

WHEREAS, on 28 May 2024, the Bidding Documents and the Invitation to Bid (IB) No. FLASK 2024-10-GSA for the subject procurement were posted at the Philippine Government Electronic Procurement System (PhilGEPS), PhilHealth website and conspicuous places located in the PhilHealth Head Office in compliance with Section 21 of the 2016 Revised IRR of Republic Act No. 9184;

WHEREAS, on 4 June 2024, the Pre-Bid Conference for the subject procurement was conducted to address the inquiries and clarifications raised by the prospective bidders. Accordingly, the Bid Bulletin No. 01 was issued on 10 June 2024;

WHEREAS, in response to the posted procurement opportunity, the following seven (7) bidders obtained the bidding documents:

- 1. Colospec Enterprise Corporation; and
- 2. Mitsui Trading Phils. Ltd. Co.
- 3. Vilcore Trading Inc.
- 4. Tanjer Enterprises
- 5. Radial Pro Trading Inc.
- 6. Grand Success Int'l. Ventures Corp.
- 7. Ramesh Trading Corporation

WHEREAS, the seven (7) prospective bidders timely submitted their respective bids before the opening of bids on 17 June 2024;

WHEREAS, in the Opening of Bids on 17 June 2024 and Bid Evaluation which was conducted on the same date, the Mitsui Trading Phils. Ltd. Co. was declared as the bidder with the Lowest Calculated Bid (LCB) with a financial bid of Two Million Five Hundred Thirty-Seven Thousand Five Hundred Twenty-Nine Pesos and Twelve Centavos (\$\mathbb{P}2,537,529.12)\$. Subsequently, Mitsui Trading Phils. Ltd. Co. was subjected for post-qualification;

WHEREAS, the Technical Working Group (TWG) for Goods and Services A (GSA) conducted the post-qualification on 1 July 2024 and presented its post-qualification report thru its Chairperson, Atty. Chelo Anne V. Cruz-Deocampo, during the BAC-GS A meeting on 10 July 2024. The TWG-GS A stated that after verification and evaluation of the eligibility, technical, financial and additional post-qualification requirements submitted by the Mitsui Trading Phils. Ltd. Co., it was found to be "responsive" with the requirements for the bidding of the subject programment and recommended that the same bidder be declared as "POST-QUALIFIED";
