RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF THE CONTRACT ON THE BIDDING FOR THE PROCUREMENT OF COMPREHENSIVE PREVENTIVE MAINTENANCE FOR FIVE (5) SETS OF PRECISION AIR-CONDITIONING UNITS (PACUs) WITH INVITATION TO BID NO. PACU 2024-27-GSB TO AMERICAN TECHNOLOGIES, INC. AS THE BIDDER WITH THE SINGLE CALCULATED RESPONSIVE BID

WHEREAS, based on the approved Purchase Request (PR) No. 24-0032-PB, the Physical Resources & Infrastructure Department (PRID) requested for the Procurement of Comprehensive Preventive Maintenance for Five (5) sets of Precision Air-Conditioning Units (PACUs) through Competitive Bidding with an Approved Budget for the Contract (ABC) of One Million Fifty Thousand Eight Hundred Forty Pesos (₱1,050,840.00) which is included in the Fifteenth (15th) Batch of Annual Procurement Plan (APP) Amendment for CY 2024;

WHEREAS, on 09 September 2024, the Bidding Documents and the Invitation to Bid (IB) No. PACU 2024-27-GSB for the subject procurement were posted at the Philippine Government Electronic Procurement System (PhilGEPS), PhilHealth website and conspicuous places located in the PhilHealth Head Office in compliance with Section 21 of the 2016 Revised IRR of Republic Act No. 9184;

WHEREAS, on 12 September 2024, a Notice was issued regarding the change of schedule for the pre-bid conference, submission and opening of bids from 10:30 a.m. to 1:30 p.m.;

WHEREAS, on 16 September 2024, the Pre-Bid Conference for the subject procurement was conducted to address inquiries and clarifications raised by the prospective bidder. Accordingly, the Bid Bulletin No. 01 was issued on 23 September 2024;

WHEREAS, in response to the posted procurement opportunity, only American Technologies, Inc. has obtained the bidding documents;

WHEREAS, American Technologies, Inc. timely submitted its bid prior to the deadline of submission and opening of bids on 30 September 2024;

WHEREAS, in the Opening of Bids and Bid Evaluation on 30 September 2024, American Technologies, Inc. have passed the financial requirements with a bid of Eight Hundred Fifty Thousand Pesos (₱850,000.00) and was declared as the bidder with the Single Calculated Bid (SCB). Subsequently, American Technologies, Inc. was subjected to post-qualification process;

WHEREAS, the Technical Working Group - Goods and Services B (TWG-GS B) conducted the post-qualification, evaluation and verification of the bid proposal and additional post-qualification requirements submitted by American Technologies, Inc. and conducted a site visit and ocular inspection on 08 October 2024;


WHEREAS, on 22 October 2024 BAC-GS-B Meeting, the TWG-GS B presented its post-qualification report thru its Chairperson, Atty. Susan G. Iduyan stating that after inspection and evaluation of the eligibility, technical, financial and additional post-qualification requirements submitted by American Technologies, Inc., it was found that the subject bid was **"COMPLIANT"** with all the requirements and the TWG has consequently recommended that the bidder be declared as **"POST-QUALIFIED"**;


WHEREAS, after due deliberation on the report and having determined that the bidder with the Single Calculated Bid passed all the criteria for post-qualification, the BAC-GS B agreed with the recommendation of the TWG-GS B to declare American Technologies, Inc. as the bidder with the Single Calculated Responsive Bid (SCRB);

PREMISES CONSIDERED, the BAC-GS B **RESOLVES**, as it is hereby resolved, to recommend to the President and CEO, as the Head of the Procuring Entity, the award of the contract on the bidding for the Procurement of Comprehensive Preventive Maintenance for Five (5) sets of Precision Air-Conditioning Units (PACUs) with Invitation to Bid No. PACU 2024-27-GSB to **AMERICAN TECHNOLOGIES, INC.** as the bidder with the Single Calculated Responsive Bid.
