### CONTRACT ON THE RE-BIDDING FOR THE PROCUREMENT OF FIRST AID KIT [IB No. RKIT 2024-33-GSA]

JAN 3 1 2025 THIS AGREEMENT made and entered into this day of 2025. in the City of San Fernando, Pangango Manila, by and between:

PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH). a government-owned and controlled corporation duly organized and existing by virtue of Republic Act No. (RA) 7875, otherwise known as the "National Health Insurance Act", as amended by RA 9241 and RA 10606, with principal office address at 17th Floor, Citystate Centre Bldg., 709 Shaw Blvd. corner Oranbo Drive, Pasig City, represented herein by its President and Chief Executive Officer (PCEO), EMMANUEL R. LEDESMA, JR., duly authorized to enter into this Contract, as evidenced by Secretary's Certificate, which is attached hereto as Annex "A", hereinafter referred to as the "PHILHEALTH";

SGS HEALTHCARE CO., a partnership duly organized and existing under and by virtue of the law of the Republic of the Philippines, with office address at Brgy. San's Vicente, Bacolor, Pampanga, represented herein by its Sales Representative, **JOSHUA G.** PLAGA who is granted full power and authority to sign this agreement under Secretary's Certificate dated October 9, 2024, attached hereto as Annex "B", herein after referred to as the "SGS".

WHEREAS, PHILHEALTH invited Bids for certain goods particularly on the **Procurement of First Aid Kit** and has accepted the bid by **SGS**, for the supply of those goods in the sum of One Million Sixteen Thousand Three Hundred Seventy-Two Pesos and Ten Centavos (\$\mathbb{P}\_{1},016,372.10) (hereinafter called "the Contract Price").

#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are 1. respectively assigned to them in the Conditions of Contract referred to.

  - (d) SGS's Bid; including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted (Annex "G"):

The Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

(e) Performance Security (Annex "H"):

Contract on the Re-Bidding for the Procurement of First Aid Kit

- Notice of Award of Contract and the Bidder's conforme thereto (Annex (f) "I"); and,
- Other contract documents that may be required by existing laws and/or the (g) PHILHEALTH in the PBDs. SGS agrees that the additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of One Million Sixteen Thousand Three 3. Hundred Seventy-Two Pesos and Ten Centavos (\$1,016,372.10) or such other sums as may be ascertained, SGS agrees to provide the Procurement of First Aid kit and services and to remedy defects therein within the warranty period in accordance with its Bid.
- **PHILHEALTH** agrees to pay **SGS** the above-mentioned sum in accordance with 4. the terms of the Bidding.
