RESOLUTION NO. 256 s. 2024

RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF THE CONTRACT ON THE RE-BIDDING FOR THE PROCUREMENT OF FIRST AID KIT WITH INVITATION TO BID NO. RKIT 2024-33-GSA TO SGS HEALTHCARE CO. AS THE BIDDER WITH THE SINGLE CALCULATED RESPONSIVE BID

WHEREAS, based on the approved Purchase Request (PR) No. 24-0043-PB, the Corporate Disaster Coordinating Committee (CDCC)/Disaster and Emergency Preparedness Program (DEPP) under the Office of the Senior Vice President – Management Services Sector (OSVP-MSS) requested for the Re-bidding for the Procurement of First Aid Kit through Competitive Bidding with an Approved Budget for the Contract (ABC) of One Million Sixty-Two Thousand Three Hundred Thirty-Seven Pesos and Fifty Centavos (P1,062,337.50) which is included in the 4th Batch of Annual Procurement Plan (APP) for CY 2024;

WHEREAS, on 26 September 2024, the Bidding Documents and the Invitation to Bid (IB) No. RKIT 2024-33-GSA for the subject procurement were posted at the Philippine Government Electronic Procurement System (PhilGEPS), PhilHealth website and conspicuous places located in the PhilHealth Head Office in compliance with Section 21 of the 2016 Revised IRR of Republic Act No. 9184;

WHEREAS, on 03 October 2024, the Pre-Bid Conference for the subject procurement was conducted to address the inquiries and clarifications raised by the prospective bidders;

WHEREAS, on 09 October 2024, the Bid Bulletin No. 01 was issued stating the issuance of Bid Bulletin No. 02 for the queries, clarifications and amendments relative to the Technical Specifications and other requirements in the Bidding Documents by the prospective bidders. Accordingly, the Bid Bulletin No. 02 was issued on 11 October 2024;

WHEREAS, on 11 October 2024, a Notice was issued stating the change of schedule and extension for the deadline of obtainment and submission and opening of bids from 15 October 2024 to 18 October 2024;

WHEREAS, in response to the posted procurement opportunity, the following two (2) bidders have obtained the bidding documents:

1. SGS Healthcare Co.; and
2. Starcare Medical Supplies.

WHEREAS, the two (2) bidders have timely submitted their respective bids before the deadline for the submission of bids on 18 October 2024;

WHEREAS, during the opening and preliminary examination of bids on 18 October 2024, Starcare Medical Supplies was found to be ineligible for non-compliance with the requirements specified in the Technical Specifications specifically on the required certifications for the subject procurement. Consequently, the bidder has manifested that it will file a Motion for Reconsideration (MR) and they were given three (3) calendar days to submit the same or until 21 October 2024;

WHEREAS, on the same date, the detailed bid evaluation was conducted wherein SGS Healthcare Co. passed the financial requirements with a financial bid of One Million Sixteen Thousand Three Hundred Seventy-Two Pesos and Ten Centavos (P1,016,372.10) and was declared as the bidder with the Single Calculated Bid (SCB). Subsequently, SGS Healthcare Co. was subjected to post-qualification process;

WHEREAS, on 22 October 2024 BAC-GS A meeting, the Secretariat for the Bids and Awards Committees (SBAC) informed the Committee that Starcare Medical Supplies submitted its MR dated 20 October 2024 which was received on the same date via electronic mail;

WHEREAS, pursuant to BAC-GS A Resolution No. 224 s. 2024, the Motion for Reconsideration (MR) filed by Starcare Medical Supplies was denied;

WHEREAS, pursuant to BAC-GS A Resolution No. 234 s. 2024, the request for extension of the period for post-qualification process by Technical Working Group - Goods and Services A (TWG-GS A) was approved;

WHEREAS, the TWG-GS A conducted the post-qualification, evaluation and verification of the bid proposal and additional post-qualification requirements submitted by SGS Healthcare Co. and conducted a site visit and ocular inspection on 30 October 2024;

WHEREAS, on 06 November 2024, the Notice pertaining to the denied MR was issued to Starcare Medical Supplies with the corresponding advice that it has seven (7) calendar days or until 13 November 2024, within which to file its protest on the resolution of the Committee, if there would be any, in accordance with R.A. No. 9184;


WHEREAS, on 13 November 2024 BAC-GS A Meeting, SBAC informed the Committee that Starcare Medical Supplies did not file any protest on the issued denied MR within the seven (7) calendar day period. Consequently, the TWG-GS A presented the post-qualification report of SGS Healthcare Co. thru its Chairperson, Atty. Chelo Anne V. Cruz-Deocampo stating that after inspection and evaluation of the eligibility, technical, financial and additional post-qualification requirements submitted by SGS Healthcare Co., it was found that the subject bid was **"COMPLIANT"** with all the requirements and the TWG has consequently recommended that the bidder be declared as **"POST-QUALIFIED"**;


WHEREAS, after due deliberation on the report and having determined that the bidder with the Single Calculated Bid passed all the criteria for post-qualification, the BAC-GS A agreed with the recommendation of the TWG-GS A to declare SGS Healthcare Co. as the bidder with the Single Calculated Responsive Bid (SCRB);

PREMISES CONSIDERED, the BAC-GS A **RESOLVES**, as it is hereby resolved, to recommend to the President and CEO, as the Head of the Procuring Entity, the award of the contract on the **Re-bidding for the Procurement of First Aid Kit with Invitation to Bid No. RKIT 2024-33-GSA** to **SGS HEALTHCARE CO.** as the bidder with the Single Calculated Responsive Bid.
