BIDS & AWARDS COMMITTEE (BAC) GOODS AND SERVICES B (GS B) RESOLUTION NO. 234 s. 2024

RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF THE CONTRACT ON THE BIDDING FOR THE PROCUREMENT OF ONE (1) LOT OF VARIOUS OFFICE TABLES AND BACK CABINETS WITH INVITATION TO BID NO. VOTBC 2024-29-GSB TO ASAHI DESIGN CENTRE INC. AS THE BIDDER WITH THE LOWEST CALCULATED RESPONSIVE BID

WHEREAS, based on the approved Purchase Request (PR) No. 24-0034-PB, the Physical Resources and Infrastructure Department (PRID) requested for the procurement of One (1) Lot of Various Office Tables and Back Cabinets through Competitive Bidding with a total Approved Budget for the Contract (ABC) of Two Million Eight Hundred Thirty-Six Thousand Five Hundred Thirty-Eight Pesos and Ninety One Centavos (\$\frac{1}{2}\$,836,538.91) which is included in the 3rd Batch of CY 2024 Annual Procurement Plan (APP) and 2nd Batch of Supplemental Annual Procurement Plan for CY 2024 with the following details:

WHEREAS, on 24 September 2024, the Bidding Documents and the Invitation to Bid (IB) No. VOTBC 2024-29-GSB for the subject procurement were posted at the Philippine Government Electronic Procurement System (PhilGEPS), PhilHealth website and conspicuous places located in the PhilHealth Head Office in compliance with Section 21 of the 2016 Revised IRR of Republic Act No. 9184;

WHEREAS, on 01 October 2024, the Pre-Bid Conference for the subject procurement was conducted to address the inquiries and clarifications raised by the prospective bidders. Accordingly, the Bid Bulletin Nos. 01 and 02 were issued on 07 October and 10 October 2024 respectively;

WHEREAS, on 10 October 2024, a Notice was issued regarding the change of schedule and that the deadline of obtainment and submission of bids as well as the opening of bids was extended from 14 October 2024 to 17 October 2024;



WHEREAS, on 15 October 2024, the Bid Bulletin No. 03 was issued to amend and/or clarify certain provisions in the bidding documents;

WHEREAS, on the same date, a Notice was issued regarding the further extension of the deadline of obtainment, submission and opening of bids from 17 October 2024 to 22 October 2024;

WHEREAS, in response to the posted procurement opportunity, the following three (3) bidders have obtained the bidding documents:

- 1. Lee Designs Industries Inc.;
- 2. Asahi Design Centre Inc.; and
- 3. Suntawood Home and Office Inc.

WHEREAS, the three (3) bidders have timely submitted their respective bid before the deadline for the submission of bids on 22 October 2024;

WHEREAS, during the opening and preliminary examination of bids on 22 October 2024, Asahi Design Centre Inc. was found to be ineligible for non-compliance with the required form and template for Price Schedule as prescribed in the standard Philippine Bidding Documents (PBD). Consequently, the bidder has manifested that they will file a Motion for Reconsideration (MR) upon notification of the result of the bidding thru telephone call;

WHEREAS, on the same date, the detailed bid evaluation was conducted finding Suntawood Home and Office Inc. to have passed the financial requirements with a bid of One Million Eight Hundred Eighty-Eight Thousand Pesos (₱1,888,000.00) and was declared as the bidder with the Lowest Calculated Bid (LCB). Subsequently, Suntawood Home and Office Inc. was subjected to post-qualification process;

WHEREAS, on 29 October 2024 BAC-GS B meeting, the Secretariat for the Bids and Awards Committees (SBAC) informed the Committee that Asahi Design Centre Inc. submitted its MR on 23 October 2024 which was received on the same date;

WHEREAS, after due deliberation on the presented documents, the MR filed by Asahi Design Centre Inc. was granted and was thereby declared as the bidder with the Lowest Calculated Bid (LCB) pursuant to BAC-GS B Resolution No. 215 s. 2024. Subsequently, Asahi Design Centre Inc. was subjected to post-qualification process;

WHEREAS, the Technical Working Group - Goods and Services B (TWG-GS B) conducted the post-qualification, evaluation and verification of the bid proposal and additional post-qualification requirements submitted by Asahi Design Centre Inc. and conducted a site visit and ocular inspection on 13 November 2024;

WHEREAS, on 19 November 2024 BAC-GS B Meeting, the TWG-GS B presented its post-qualification report thru its Chairperson, Atty. Susan G. Iduyan, MPA, CESE, stating that after inspection and evaluation of the eligibility, technical, financial and additional post-qualification requirements submitted by Asahi Design Centre Inc., it was found that the subject bid was "COMPLIANT" with all the requirements and the TWG has consequently recommended that the bidder be declared as "POST-QUALIFIED";

WHEREAS, after due deliberation on the report and having determined that the bidder with the Lowest Calculated Bid passed all the criteria for post-qualification, the BAC-GS B agreed with the recommendation of the TWG-GS B to declare Asahi Design Centre Inc. as the bidder with the Lowest Calculated and Responsive Bid (LCRB) with a financial bid of One Million Eight Hundred Sixty-Seven Thousand Four Hundred Pesos (₱1,867,400.00);

PREMISES CONSIDERED, the BAC-GS B RESOLVES, as it is hereby resolved, to recommend to the President and CEO, as the Head of the Procuring Entity, the award of the

contract on the bidding for the **Procurement of One (1) Lot of Various Office Tables and Back Cabinets** with Invitation to Bid No. VOTBC 2024-29-GSB to **ASAHI DESIGN CENTRE INC.** as the bidder with the Lowest Calculated and Responsive Bid.
