**PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH)**, a government owned and controlled corporation duly organized and existing by virtue of Republic Act No. (RA) 7875, otherwise known as the "National Health Insurance Act", as amended by RA 9241 and RA 10606, with principal office address at 17<sup>th</sup> Floor, Citystate Centre Bldg., 709 Shaw Blvd. corner Oranbo Drive, Pasig City, represented herein by its President and Chief Executive Officer (PCEO), **EMMANUEL R. LEDESMA, JR.**, duly authorized to enter into this Contract, as evidenced by Secretary's Certificate, which is attached hereto as Annex "A", hereinafter referred to as the "PHILHEALTH";

-and-

**RADENTA TECHNOLOGIES INC.**, a corporation duly organized and existing under and by virtue of the law of the Republic of the Philippines, with office address at Unit 2-BC 2<sup>nd</sup> Floor CBC Corporate Center, 724 Shaw Blvd. Brgy. Wack-wack, Mandaluyong City, represented herein by its Account Manager, **MHAR BEN R. ARANDA**, who is granted full power and authority to sign this agreement under Secretary's Certificate dated August 29, 2024, attached hereto as Annex "B", hereinafter referred to as the "RADENTA"

**WHEREAS, PHILHEALTH** invited Bids for certain goods and ancillary services particularly on the **Procurement of Cloud Subscription for eClaims Submission** and has accepted the Bid by **RADENTA**, for the supply of those goods and services in the sum of **Thirty-Nine Million Five Hundred Thousand Pesos (P39,500,000.00)** (hereinafter called "the Contract Price").

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz:
  - (a) **PHILHEALTH's** Secretary's Certificate (**Annex "A"**);
  - (b) **RADENTA's** Secretary's Certificate (**Annex "B"**);
  - (c) Philippine Bidding Documents (PBDs);
    - (i) Schedule of Requirements (**Annex "C"**);
    - (ii) Technical Specifications (**Annex "D"**);
    - (iii) General and Special Conditions of the Contract (**Annex "E"**); and
    - (iv) Bid Bulletin No. 01 (**Annex "F"**);
  - (d) **RADENTA's** Bid; including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted (**Annex "G"**);

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents

- (e) Performance Security (**Annex "H"**);
- (f) Notice of Award of Contract and the Bidder's conforme thereto (**Annex "I"**); and,
- (g) Other contract document that may be required by existing laws and/or the **PHILHEALTH** in the PBDs. **RADENTA agrees that the additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

- 3. In consideration for the sum of **Thirty-Nine Million Five Hundred Thousand Pesos (P39,500,000.00)** or such other sums as may be ascertained, **RADENTA** agrees to provide the **Procurement of Cloud Subscription for eClaims Submission** and services and to remedy defects therein within the warranty period in accordance with its Bid.
- 4. **PHILHEALTH** agrees to pay **RADENTA** the above-mentioned sum in accordance with the terms of the Bidding.




