BIDS & AWARDS COMMITTEE (BAC) – INFORMATION TECHNOLOGY RESOURCES A (ITR A) RESOLUTION NO. <u>277</u> s. 2024

RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF THE CONTRACT ON THE BIDDING FOR THE PROCUREMENT OF CLOUD SUBSCRIPTION FOR eCLAIMS SUBMISSION WITH INVITATION TO BID NO. CLOUD 2024-20-ITRA TO RADENTA TECHNOLOGIES INC. AS THE BIDDER WITH THE LOWEST CALCULATED RESPONSIVE BID

WHEREAS, based on the approved Purchase Request (PR) No. 24-0031-PB, the Information Technology Management Department (ITMD) requested for the Procurement of Cloud Subscription for eClaims Submission through Competitive Bidding with an Approved Budget for the Contract (ABC) of Thirty Nine Million Eight Hundred Forty Five Thousand Seven Hundred Seventy-Four Pesos and Fifty Centavos (\$\bar{P}_{39},845,774.50)\$ which is included in the 4th Batch of CY 2024 Annual Procurement Plan (APP);

WHEREAS, on 13 August 2024, the Bidding Documents and the Invitation to Bid (IB) No. CLOUD 2024-20-ITRA for the subject procurement were posted at the Philippine Government Electronic Procurement System (PhilGEPS), PhilHealth website and conspicuous places located in the PhilHealth Head Office in compliance with Section 21 of the 2016 Revised IRR of Republic Act No. 9184;

WHEREAS, on 20 August 2024, the Pre-Bid Conference for the subject procurement was conducted to address the inquiries and clarifications raised by the prospective bidders. Accordingly, the Bid Bulletin No. 01 was issued on 27 August 2024;

WHEREAS, on 29 August 2024, a Notice was issued regarding the change of schedule and that the deadline of obtainment and submission of bids as well as the opening of bids was extended from 02 September 2024 to 03 September 2024;

WHEREAS, in view of the suspension of work in government offices in the National Capital Region (NCR) due to the inclement weather brought about by Tropical Storm "Enteng", the Notice of Postponement, Change of Schedule and Extension for the deadline of Obtainment and Submission and Opening of Bids was issued on 03 September 2024 stating that these procurement activities were postponed and moved from 03 September 2024 to 04 September 2024;

WHEREAS, in response to the posted procurement opportunity, the following two (2) bidders have obtained the bidding documents:

- 1. Radenta Technologies Inc.; and,
- 2. eBIZolution Inc.

WHEREAS, the two (2) bidders have timely submitted their respective bids before the deadline for the submission of bids on 04 September 2024;

WHEREAS, during the opening of bids and subsequent bid evaluation on 04 September 2024, eBIZolution Inc. was declared as the bidder with the Lowest Calculated Bid (LCB) and was subjected to post-qualification process;

WHEREAS, pursuant to BAC-ITR A Resolution No. 204 s. 2024, eBIZolution Inc. was declared as "POST-DISQUALIFIED" based on the recommendation of the Technical Working Group –



Information Technology Resources A (TWG-ITR A) as presented in their post-qualification report on 09 October 2024;

WHEREAS, pursuant to BAC-ITR A Resolution No. 246 s. 2024, the request of the TWG-ITR A for the extension of the conduct of post-qualification and submission of the post-qualification report of the second (2nd) Lowest Calculated Bid (LCB) was approved on 15 October 2024;

WHEREAS, the TWG-ITR A conducted the post-qualification, evaluation and verification of the bid proposal and additional post-qualification requirements submitted by Radenta Technologies Inc. being the second (2nd) Lowest Calculated Bid (LCB) and conducted a site visit and ocular inspection on 22 October 2024;

WHEREAS, on 06 November 2024, the Notice of Post-Disqualification was issued to eBIZolution Inc., sent via electronic mail, with the corresponding advice that it has three (3) calendar days or until 09 November 2024, within which to file its Motion for Reconsideration (MR), if there would be any, in accordance with R.A. No. 9184;

WHEREAS, during the 14 November 2024 BAC-ITR A Meeting, SBAC informed the Committee that eBIZolution Inc. did not file a Motion for Reconsideration (MR) and that their three (3) calendar day period to file its MR has already lapsed;

WHEREAS, given the foregoing, the BAC-ITR A resolved to proceed with the presentation of the post-qualification report of Radenta Technologies Inc. being the second (2nd) LCB. The TWG-ITR A, thru its Vice-Chairperson, Jose Marte L. Puhawan stated that after verification and evaluation of the eligibility, technical, financial and additional post-qualification requirements submitted by Radenta Technologies Inc. during their conduct of the post-qualification, it was found that the subject bid was "COMPLIANT" with all the requirements and the TWG-ITR A has consequently recommended that the bidder be declared as "POST-QUALIFIED";

WHEREAS, after due deliberation on the report and having determined that the bidder with the second (2nd) LCB has passed all the criteria for post-qualification, the BAC-ITR A agreed with the recommendation of the TWG-ITR A to declare Radenta Technologies Inc. as the bidder with the Lowest Calculated Responsive Bid (LCRB) with a financial bid of Thirty Nine Million Five Hundred Thousand Pesos (₱39,500,000.00);

PREMISES CONSIDERED, the BAC-ITR A RESOLVES, as it is hereby resolved, to recommend to the President and CEO, as the Head of the Procuring Entity, the award of the contract on the bidding for the Procurement of Cloud Subscription for eClaims Submission with Invitation to Bid No. CLOUD 2024-20-ITRA to RADENTA TECHNOLOGIES INC. as the bidder with the Lowest Calculated Responsive Bid.
