

CONTRACT ON THE BIDDING FOR THE

THIS AGREEMENT made and entered into this \_\_\_\_\_ day of \_\_\_\_\_ 2024, in the City of PASIG CITY, Metro Manila, by and between:

**PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH)**, a government owned and controlled corporation duly organized and existing by virtue of Republic Act No. (RA) 7875, otherwise known as the "National Health Insurance Act", as amended by RA 9241 and RA 10606, with principal office address at 17<sup>th</sup> Floor, Citystate Centre Bldg., 709 Shaw Blvd. corner Oranbo Drive, Pasig City, represented herein by its President and Chief Executive Officer (PCEO), **EMMANUEL R. LEDESMA, JR.**, duly authorized to enter into this Contract, as evidenced by Secretary's Certificate, which is attached hereto as Annex "A", hereinafter referred to as the "**PHILHEALTH**";

-and-

**DBQUEST, INC., NTT DATA PHILIPPINES, INC. AND NTT PHILIPPINES SOLUTIONS INC.**, a joint venture duly organized and existing under and by virtue of the law of the Republic of the Philippines, with office address at Unit 2606 Antel Global Corporate Center #3 Julia Vargas Avenue, Ortigas Center, Pasig City, at 28/F 88 Corporate Center Sedenor corner Valero Sts., Salcedo Village, Makati City and at 26/F Zuellig Building, Makati Avenue corner Paseo De Roxas, Makati City, respectively, represented herein by its Account Manager, **EDWIN I. TAGALA** who is granted full power and authority to sign this agreement under Secretary's Certificate dated 23 September 2024, attached hereto as Annex "B", hereinafter referred to as the "**DBQUEST, NTT DATA AND NTT PHILS. JOINT VENTURE**";

**WHEREAS, PHILHEALTH** invited Bids for certain goods and ancillary services particularly on the **Procurement of Enterprise Database Server for Production** and has accepted the Bid by **DBQUEST, NTT DATA AND NTT PHILS. JOINT VENTURE**, for the supply of those goods in the sum of **One Hundred Thirty-Eight Million Nine Hundred Sixty Thousand Pesos (P138,960,000.00)** (hereinafter called "**the Contract Price**").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz:
  - (a) **PHILHEALTH's** Secretary's Certificate (**Annex "A"**);
  - (b) **DBQUEST, NTT DATA AND NTT PHILS. JOINT VENTURE's** Secretary's Certificate (**Annex "B"**);
  - (c) Philippine Bidding Documents (PBDs);
    - (i) Schedule of Requirements (**Annex "C"**);
    - (ii) Technical Specifications (**Annex "D"**);
    - (iii) General and Special Conditions of the Contract (**Annex "E"**); and
    - (iv) Bid Bulletin No. 01 (**Annex "F"**);

- (d) **DBQUEST, NTT DATA AND NTT PHILS. JOINT VENTURE's** Bid; including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted (**Annex "G"**);

The Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- (e) Performance Security (**Annex "H"**);  
(f) Notice of Award of Contract and the Bidder's conforme thereto (**Annex "I"**);  
(g) Joint Venture Agreement (Annex "J"); and,  
(h) Other contract document that may be required by existing laws and/or the **PHILHEALTH** in the PBDs. **DBQUEST, NTT DATA AND NTT PHILS. JOINT VENTURE** agrees that the additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **One Hundred Thirty-Eight Million Nine Hundred Sixty Thousand Pesos (P138,960,000.00)** or such other sums as may be ascertained, **DBQUEST, NTT DATA AND NTT PHILS. JOINT VENTURE** agrees to provide the **Procurement of Procurement of Enterprise Database Server for Production** and to remedy defects therein within the warranty period in accordance with its Bid.
4. **PHILHEALTH** agrees to pay **DBQUEST, NTT DATA AND NTT PHILS. JOINT VENTURE** the above-mentioned sum in accordance with the terms of the Bidding.
