**RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF THE CONTRACT ON THE BIDDING FOR THE PROCUREMENT OF ONE (1) LOT REPLICATION LICENSES AND SUPPORT WITH INVITATION TO BID NO. RLS 2024-03-ITRB TO RADENTA TECHNOLOGIES INC. AS THE BIDDER WITH THE LOWEST CALCULATED RESPONSIVE BID**

**WHEREAS**, based on the approved Purchase Request (PR) No. 24-0006-PB, the Information Technology Management Department (ITMD) requested for the Procurement of One (1) Lot Replication Licenses and Support through Competitive Bidding with the Approved Budget for the Contract (ABC) of Thirty-Nine Million Nine Hundred Thousand Pesos (P39,900,000.00) which is included in the 4<sup>th</sup> Batch of CY 2024 Annual Procurement Plan (APP);

**WHEREAS**, on 26 April 2024, the Bidding Documents and the Invitation to Bid (IB) No. RLS 2024-03-ITRB for the subject procurement were posted at the Philippine Government Electronic Procurement System (PhilGEPS), PhilHealth website and conspicuous places located in the PhilHealth Head Office in compliance with Section 21 of the 2016 Revised IRR of Republic Act No. 9184;

**WHEREAS**, on 3 May 2024, the Pre-Bid Conference for the subject procurement was conducted to address the inquiries and clarifications raised by the prospective bidders. Accordingly, the Bid Bulletin No. 01 was issued on 8 May 2024;

**WHEREAS**, in response to the posted procurement opportunity, the following two (2) bidders obtained the bidding documents:

1. Radenta Technologies Inc.; and
2. DBQuest, Inc.

**WHEREAS**, on 15 May 2024, Radenta Technologies Inc. and DBQuest, Inc. timely submitted its bid for the subject procurement. However, the scheduled opening of bids on the same date has been postponed and the Bids and Awards Committee (BAC)- Information Technology Resources (ITR) B issued a Notice of Change of Schedule for the said activity from 15 May 2024 to 16 May 2024;

**WHEREAS**, in the Opening of Bids on 16 May 2024 and Bid Evaluation which was conducted on the same date, the Radenta Technologies, Inc. was declared as the bidder with the Lowest Calculated Bid (LCB) with a financial bid of Thirty-Eight Million One Hundred Ninety-Two Thousand Pesos (P38,192,000.00). Subsequently, Radenta Technologies Inc. was subjected for post-qualification;


**WHEREAS**, the Technical Working Group (TWG)-Information Technology Resources (ITR) B conducted the post-qualification on 22 May 2024 and presented its post-qualification report thru its Chairperson, Atty. Roel S. Espera, during the BAC-ITR B meeting on 29 May 2024. The TWG-ITR B stated that after verification and evaluation of the eligibility, technical, financial and additional post-qualification requirements submitted by the Radenta Technologies Inc., it was found to be “responsive” with the requirements for the bidding of the subject procurement and recommended that the same bidder be declared as “POST-QUALIFIED”;

**WHEREAS**, the BAC-ITR B concurred with the recommendation of the TWG-ITR B to declare Radenta Technologies Inc. as the bidder with the Lowest Calculated Responsive Bid (LCRB);




