 - (d) **QUARTZ**'s Bid; including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted **(Annex "G")**;

The Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's

response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- (g) Other contract document that may be required by existing laws and/or the **PHILHEALTH** in the PBDs. **QUARTZ** agrees that the additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of Four Million Nine Hundred Twelve Thousand Eight Hundred Eighteen Pesos (\$\mathbb{P}4,912,818.00)\$ or such other sums as may be ascertained, QUARTZ agrees to provide the Procurement of Toner Cartridge, HP CF281A (HP81A) Black Laserjet and to remedy defects therein within the warranty period in accordance with its Bid.
- 4. **PHILHEALTH** agrees to pay **QUARTZ** the above-mentioned sum in accordance with the terms of the Bidding.
