5. In case of re-ordered/replaced items, which cannot be replaced within seven (7) calendar days from notice, PhilHealth shall demand full refund of payment made "on cash" or "on check" three (3) calendar days.
6. Deliveries should be made within 8:00AM to 5:00PM on working days and/or before the date stipulated in the PO.
