

**CONTRACT FOR THE SUPPLY AND DELIVERY OF SEMI-EXPENDABLE
FURNITURE AND FIXTURES – VARIOUS CHAIRS, TABLES AND
CABINETS 2024-012-G LOT 1 (VARIOUS CHAIRS) AND LOT 3 (VARIOUS
CABINETS) FOR PHILHEALTH REGIONAL OFFICE III (PRO III)**

THIS CONTRACT made and entered into this JAN 24 2025, 2025
between:

PHILIPPINE HEALTH INSURANCE CORPORATION, a government owned and controlled corporation created and existing by virtue of R.A. 7875, as amended by R.A. 9241 and R.A. 10606, otherwise known as the "National Health Insurance Act of 2013" and R.A. 11223, otherwise known as the "Universal Health Care Act", with office address at 19th Floor, City State Center Bldg., 709 Shaw Blvd., Barangay Oranbo, Pasig City, represented herein by its **Acting Vice President of PhilHealth Regional Office III (PRO III) HENRY V. ALMANON**, with office address at PhilHealth Bldg., No. 168 Lazatin Blvd., San Agustin, City of San Fernando, Pampanga, duly authorized to enter into this Contract, as evidenced by Corporate Order No. 2018-0026 New Delegation and Signing Authority (DSA) in the Head Office and Regional Offices dated April 10, 2018, which is attached hereto as Annex "A", hereinafter referred to as the "**PHIC**"

VERDE LINEAR CORPORATION with trade name **PROGRESS HOME & OFFICE FURNISHINGS**, a private corporation duly registered, organized and existing under the laws of the Republic of the Philippines and registered with Securities and Exchange Commission (SEC) with Certificate No. CS093-000320 with business address at #73 Panay Ave., Brgy. Paligsahan, Quezon City, Metro Manila, NCR, represented herein by its **Project Sales Representative, DELMER B. EBUEZA**, duly authorized to enter into Contract, as evidenced by Secretary's Certificate dated December 4, 2024, which is attached hereto as Annex "B", hereinafter referred to as "**SUPPLIER**"

WHEREAS, the **PHIC** invited Bidders for the Supply and Delivery of Semi-Expendable Furniture and Fixtures – Various Chairs, Tables, and Cabinets for PRO III 2024-012-G – Lot 1 (Various Chairs) and Lot 3 (Various Cabinets) by posting the Invitation to Bid (IB) in the PhilGEPS and PhilHealth website and in conspicuous place in PRO III Building with bulletin board reserved for posting, pursuant to *Section 21. Advertising and Contents of the Invitation to Bid of RIRR of R.A. 9184*;

WHEREAS, **PHIC** has accepted a Bid by "**SUPPLIER**" for the "Supply and Delivery of Semi-Expendable Furniture and Fixtures – Various Chairs, Tables, and Cabinets for PRO III 2024-012-G – Lot 1 (Various Chairs) and Lot 3 (Various Cabinets)" in the sum of NINE HUNDRED FIFTY-THREE THOUSAND TWO HUNDRED FIFTY-EIGHT PESOS ONLY (**Php 953,258.00**) (hereinafter called "the Contract Price").

NOW THIS CONTRACT WITNESSETH AS FOLLOWS:

1. In this Contract words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Contract, *viz.*:
 - a. Philippine Bidding Documents (PBDs):
 - i. Schedule of Requirements;
 - ii. Technical Specification;

- iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - c. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - d. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In any case of conflict arising from the interpretation or application of the provisions of this contract, the Parties shall immediately exhaust earnest efforts towards an amicable settlement of the issues, through mutual consultation and other available alternative means of dispute resolution, as a condition precedent to any legal action or proceeding arising under this Contract shall be filed exclusively before the competent courts of Pampanga.
 4. In consideration for the sum of NINE HUNDRED FIFTY-THREE THOUSAND TWO HUNDRED FIFTY-EIGHT PESOS ONLY (**Php953,258.00**) or such other sums as may be ascertained, "**SUPPLIER**" agrees to the Supply and Delivery of Semi-Expendable Furniture and Fixtures – Various Chairs, Tables, and Cabinets for PRO III 2024-012-G – Lot 1 (Various Chairs) and Lot 3 (Various Cabinets) in accordance with his/her/its Bid.
 5. The **PHIC** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


