## BAC RESOLUTION NO. 2024 - <u>15</u>

## Resolution Recommending the Award of Contract to AQUAMARINE RECREATIONAL CENTER for the Lease of Venue including Meals for the Conduct of PRO IV-B Employees Day-Sports Fest for CY 2024 (NP-LOV-PRO4B-2024-فت)

WHEREAS, Rule XVI, Section 48.1 of the Revised IRR of R.A. No. 9184 provides that "Subject to the prior approval of the HOPE, and whenever justified by the conditions provided in this Act, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the <u>alternative methods of procurement</u> provided in this Rule. In all instances, the Procuring Entity shall ensure that the most advantageous price for the Government is obtained."

**WHEREAS**, Section 53 of the R.A. No. 9184 provides that **Negotiated Procurement** is a method of procurement of Goods, whereby the Procuring Entity directly negotiates a contract with technically, legally and financially capable supplier;

WHEREAS, under Section 53.10 of the IRR of R.A. No. 9184, lease of venue including meals is included in the instances where the alternative mode of Negotiated Procurement may be allowed under R.A. 9184 and its 2016 Revised IRR;

WHEREAS, this "Lease of Venue including Meals for the Conduct of PRO IV-B Employees Day-Sports Fest for CY 2024" with an Approved Budget for the Contract (ABC), of Two Hundred Seventy-Eight Thousand Five Hundred Pesos (Php 278,500.00), inclusive of applicable taxes is included in the approved Annual Procurement Plan (APP) CY 2024 of PRO IV-B per BAC Resolution No. 2024-53 dated August 2, 2024;

WHEREAS, on July 16, 2024, the End-User has secured Certification from Lipa City Administrator's Office that the Lipa City Government has no available government facility for the conduct of PhilHealth Regional Office IV-B Employees Day on August 31, 2024 to September 14, 2024;

WHEREAS, on August 12, 2024, the End-User sent Request for Quotation (RFQ) to three (3) prospective service providers, namely:

- 1) LAX Sports Center
- 2) Aquamarine Recreational Center
- 3) Summit Point Golf and Country Club, Inc.

WHEREAS, only two (2) service providers submitted its quotation on time. The total amount quoted by both service providers are as follows:

WHEREAS, the quotation of Aquamarine Recreational Center in the amount of Two Hundred Seventy-Eight Thousand Five Hundred Pesos (Php 278,500.00) which is <u>within the ABC</u>, was subsequently declared as the Lowest Calculated Quotation (LCQ);

**WHEREAS**, based on compliance rating with technical specification, Aquamarine Recreational Center garnered a total factor of 95.70% with the passing rate of 80%.

WHEREAS, on August 29, 2024, the End-User endorsed to the BAC through its Secretariat, all documents relative to the "Procurement of Lease of Venue including Meals for the Conduct of PRO IV-B Employees Day-Sports Fest for CY 2024" with the **request for the possible recommendation of award**;

WHEREAS, on September 6, 2024, the BAC determined that Aquamarine Recreational Center <u>complied</u> with the technical, legal and financial requirements of procurement project.

WHEREAS, after careful verification, validation and ascertainment of all statements and documents submitted by Aquamarine Recreational Center, its price quotation was found to be **<u>reasonable</u>** based on comparative market analysis on the prevailing lease rates for venue within the vicinity of the selected location and <u>**responsive**</u> to all the requirements set forth in the technical specifications, and hence declared the same as **Lowest Calculated and Responsive Quotation (LCRQ)**;

WHEREAS, on that same meeting, the BAC Recommended the award of the <u>contract</u> for the procurement of Lease of Venue including Meals for the Conduct of PRO IV-B Employees Day-Sports Fest for CY 2024 to Aquamarine Recreational Center;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the Members of the PRO IV-B Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

1. To declare that the submitted quotation of Aquamarine Recreational Center is reasonable and responsive to all the requirements and conditions specified for the Lease of Venue including Meals for the conduct of PRO IV-B Employees Day-Sports Fest for CY 2024 and is within the Approved Budget for the Contract under NP-LOV-PRO4B-2024-05;

2. To recommend the issuance of award to Aquamarine Recreational Center for having submitted the Lowest Calculated and Responsive Quotation (LCRQ) and in the amount of Two Hundred Seventy-Eight Thousand Five Hundred Pesos (Php 278,500.00); and

3. To **recommend for approval by the Regional Vice President**, Head of the Procuring Entity of the PhilHealth Regional Office IV-B (PRO IV-B), of the foregoing.
