BAC RESOLUTION NO. 2024 - 62

Resolution Recommending the Issuance of Award of the Contract on the Procurement of Office Furniture and Fixtures of PRO IV-B To Progress Home & Office Furnishings (IB No. PRO4B-2024-01)

WHEREAS, on June 4, 2024, in accordance with Section 21.2 of the RIRR of R.A. No. 9184 the BAC Secretariat advertised and posted the Invitation to Bid for the Procurement of Office Furniture and Fixtures of PRO IV-B under IB No. PRO4B-2024-01, in the PhilGeps website, PhilHealth official website and in a conspicuous place within the premises of PRO4B;

WHEREAS, the total Approved Budget for the Contract (ABC) for said procurement project amounts to Two Million One Hundred Seventy Thousand Two Hundred Forty Two Pesos (Php 2,170,242.00);

WHEREAS, on June 13, 2024, the BAC held a Pre-Bid Conference, to discuss the eligibility requirements and the technical and financial components of the contract to be bid:

WHEREAS, Bid Bulletin No. 2024-01 (June 14, 2024), amending and clarifying information in the bidding documents, was posted continuously at the PhilGeps website, PhilHealth official website and in a conspicuous place within the premises of PRO IV-B at least seven (7) days before the deadline for submission and opening of bids, pursuant to Section 22.5.2 of the RIRR of RA 9184;

WHEREAS, on July 5, 2024, the deadline for the submission and receipt of bids as well as the date of opening thereof, three (3) bidders namely:

- Progress Home and Office Furnishings;
- Design Excellence Home and Office System Company; and.
- Asahi Design Centre, Inc.;

WHEREAS, as read, the bid proposals from all three (3) bidders where all is within ABC, and thus accepted by the BAC;

WHEREAS, after the bid evaluation, the BAC declared the submission of Progress Home and Office Furnishings ("Progress Home" for brevity), as the Lowest Calculated Bid (LCB) in the amount of One Million Seven Hundred Sixty Eight Thousand Three Hundred Sixty Five Pesos (Php 1,768,365.00);

WHEREAS, pursuant to Section 34.2 of the RIRR of RA 9184, the bid of Progress Home and Office Furnishings has been subjected it Post Qualification, to determine whether it complies with and is responsive to all the requirements and conditions specified in the Bidding Documents;



WHEREAS, as provided by Rule X, Section 34 of the RIRR of RA 9184, the Technical Working Group (TWG) verified, validated and ascertained all statements made and documents submitted by the bidder and provided the members of the Committee the TWG reports;

WHEREAS, on post qualification meeting held on August 16, 2024, the TWG reported that Progress Home and Office Furnishings has fully complied with the requirements for the Procurement of Office Furniture and Fixtures of PRO IV-B per IB No. PRO 4B-2024-01;

WHEREAS, on the same date, the BAC, upon the evaluation of the additional documents required under Section 34.2 of the RIRR of RA 9184 and the TWG Report determined that **Progress Home and Office Furnishings** passed all criteria for post qualification and declared the bid to be the **Lowest Calculated Responsive Bid (LCRB)** and agreed to recommend the award of the contract to **Progress Home and Office Furnishings**;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the Members of the PRO IV-B Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- 1. To declare that the submitted proposal of **Progress Home and Office Furnishings** is compliant with and is responsive to all the requirements and conditions specified in the Bidding Documents for IB No. PRO4B-2024-01 and is within the Approved Budget for the Contract;
- 2. To recommend the issuance of award to Progress Home and Office Furnishings for the Procurement of Office Furniture and Fixtures of PRO IV-B under IB No. PRO4B-2024-01 for having submitted the Lowest Calculated Responsive Bid (LCRB) in the amount of One Million Seven Hundred Sixty Eight Thousand Three Hundred Sixty Five Pesos (Php 1,768,365.00);
- 3. To recommend for approval by the Regional Vice President, Head of the Procuring Entity of the PhilHealth Regional Office IV-B (PRO IV-B), of the foregoing.
