

**PRO – CAR PROCUREMENT UNIT****Resolution No. 03 s, 2024****RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO GCMED PHARMACEUTICAL DISTRIBUTOR FOR THE PROCUREMENT OF MEDICAL SUPPLIES OF PRO-CAR FOR CY 2024**

**WHEREAS**, the PhilHealth Regional Office – Cordillera Administrative Region (PRO-CAR), under its Annual Procurement Plan (APP) for CY 2024, intends to procure Medical Supplies of PRO-CAR for CY 2024, through Small Value Procurement Unit with an Approved Budget for the Contract (ABC) of Two Hundred Seventy Thousand Eight Pesos and Eighty Four Centavos (P270,008.84);

**WHEREAS**, the procurement project was posted at the Philippine Government Electronic Procurement System (PhilGEPS) website from January 27, 2024 to February 02, 2024 per PhilGEPS Reference No. 10506486;

**WHEREAS**, the General Services Unit (GSU) distributed Request for Quotations (RFQs) to various suppliers and in response to said request, seven (7) suppliers quoted for the said procurement project;

**WHEREAS**, upon careful evaluation of the quotations and eligibility documents, the quotation of GCMED Pharmaceutical Distributor in the amount of Two Hundred Four Thousand Forty Six Pesos and Eighty Centavos (P204,046.80), has been found to be single calculated, compliant and responsive for the following items:


**NOW THEREFORE**, premises duly considered, the Procurement Unit and the End-user resolve as it is hereby **RESOLVED**:
