

CONTRACT AGREEMENT FOR THE PROCUREMENT OF CY 2024 ANNUAL PHYSICAL EXAM FOR 182 EMPLOYEES

THIS AGREEMENT made on the _____ day of 2 OCT 2024 2024 between PHILIPPINE HEALTH INSURANCE CORPORATION, PhilHealth Regional Office – Cordillera Administrative Region of the Philippines (hereinafter called “the Entity”) as represented by the Regional Vice President **DOMINGA A. GADGAD, MD, MPA**, who is authorized for this purpose under PhilHealth Corporate Order No. 2018-0026 on the New Delegation and Signing Authority (DSA) in the Head Office and Regional Offices, herein attached as Annex “A” of the one part and QA Diagnostic Laboratory, as represented by the Authorized Signatory, **KARLA P. NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs) (Annex “C”);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted (Annex “D”);
 - iii. Performance Security (Annex “F”);
 - iv. Notice of Award of Contract; and the Bidder’s conforme thereto

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation (Annex “E”);

4. The PhilHealth Regional Office – Cordillera Administrative Region agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




