CY 2024 PERFORMANCE REPORT OF THE COMMITTEE ON APPEALED ADMINISTRATIVE CASES (CAAC)

Under the Revised Implementing Rules and Regulations of the National Health Insurance Act of 2013 (RA 7875, as amended by RA 9241 and 10606), the Committee on Appealed Administrative Cases (CAAC) is mandated to study and review the decisions on administrative cases against healthcare providers brought before it on appeal. It shall have the power to study and report the appellant's compliance with all the requirements of appeal, review the grounds of appeal, and provide reports and recommendations to the Board *en banc*. With the concurrence and approval of the majority of all its members, the CAAC shall elevate its written report and draft decision to the Board *en banc* for the latter's consideration and approval.

IV. CASES REVIEWED

As of December 31, 2024, the CAAC has undertaken a meticulous and comprehensive review of thirty-six (36) cases, thirty-two (32) of which are Appeals and four (4) are Motions for Reconsideration (MR). With an average of three (3) to four (4) cases per meeting, each case was examined by CAAC with the utmost diligence to ensure fair and well-founded decisions, demonstrating its commitment to thorough deliberation and just resolution. V. POLICY RECOMMENDATION

In alignment with the Board's directives to review and amend the quasi-judicial powers of the Corporation, the CAAC collated and studied the underlying aspects and nature of the cases filed with the Board. These included cases filed beyond the appeal period, repeating offenses, cases filed against the Medical Director instead of the physician, and numerous findings of breach of warranties of accreditation without any findings of guilt for filing multiple claims.

A Technical Working Group (TWG) was established, composed of Members of the PhilHealth Board, the Office of the Corporate Secretary, legal representatives from both the central and regional offices, and heads of concerned departments of the central office. Leveraging the expertise of its members, the TWG reviewed topics such as the qualifications and procedures for appealing claims, penalties that suspend accreditation, and the reinstatement of penalized Health Care Providers under the Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 7875, as amended, and R.A. No. 11223.

On determining the end goal of the TWG, the members outlined a timeline for completing the amendments, targeting finalization in CY 2025. This marks a significant milestone in the Corporation's steadfast commitment to excellence and the broader goal of achieving universal health care in the Philippines.
