CY 2024 Accomplishment Report of the Benefits Committee

Approved by the Benefits Committee on February 11, 2025

The Benefits Committee is a sub-committee under the PhilHealth Board whose main responsibility is to provide policy directions and set a medium-term benefits development agenda, including a review of the provider payment mechanism, in line with the progressive realization of Universal Health Care (UHC) law. It also evaluates proposed current benefit designs, monitors the overall utilization and implementation of benefit policy implications, and recommends corrective action to the Board and provides policy directions to the Health Finance Policy Sector.

The Benefits Committee, in its commitment to provide policy directions on healthcare benefits, approved advanced policies toward the realization of the UHC Law as follows:

I. A COMPREHENSIVE REVIEW OF EXISTING BENEFIT PACKAGES

After recent years of resolving the unwarranted circumstances caused by COVID – 19 for providing financial and immediate healthcare services, the Committee assured to address the prolonged burden of Out-Of-Pocket (OOP) expenses to all Filipinos through crafting, improving and enhancing the Benefit Packages as one of the objectives of the Universal Health Care (UHC) Act.

The Committee continuously provided and improved the benefit packages to address the never ending burden of OPP to all Filipinos. Therefore, the Committee approved the following benefit packages:

A. ENHANCEMENT OF BENEFIT PACKAGES

- 1. Adjustment of Case-based Payments (30% Inflation Adjustment Factor)
- 2. Hemodialysis Package and its expansion of coverage:
 - a. Revision 1 & 2
 - b. QS Maintenance of Hemodialysis Procedure
- 3. Z Benefits for Breast Carcinoma
- 4. Peritoneal Dialysis Benefit Package
- 5. Z Benefit Package for Kidney Transplantation
- 6. Z Benefit Package for Open Heart Surgery
 - Coronary Artery Bypass Graft Surgery;
 - Closure of Ventricular Septal Defect; and
 - VSD with Aortic Stenosis, Total Correction of Tetralogy of Fallot)
- 7. Fifty Percent (50%) Adjustment of Selected Case Rates
- 8. Enhancement of PhilHealth Konsulta Benefit Package
- 9. Lifting of the Single Period of Confinement (SPC) Rule.
- 10. Outpatient Therapeutic Care Services for Severe Acute Malnutrition (SAM) for children 5 years and below
- 11. Services for Physical Medicine and Rehabilitation, Including the Coverage for Assistive Mobility Devices





- 12. Preventive Oral Health Services in Primary Care
- 13. Rare Diseases (Z Miracles)
- 14. Post Kidney Transplantation (Post-KT) Services
- 15. Emergency Care Package
- 16. Optometric Services
- 17. Bronchial Asthma in Acute Exacerbation
- 18. Bacterial Sepsis of Newborn
- 19. Dengue Hemorrhagic Fever Severe
- 20. Ischemic Heart Disease with Myocardial Infarction (IHD-STEMI)
- 21. Cataract Extraction
