

CY 2025 PERFORMANCE REPORT OF THE COMMITTEE ON APPEALED ADMINISTRATIVE CASES (approved by the CAAC on January 09, 2026)

Under the Revised Implementing Rules and Regulations of the National Health Insurance Act of 2013 (RA 7875, as amended by RA 9241 and 10606), the Committee on Appealed Administrative Cases (CAAC) is mandated to study and review the decisions on administrative cases against healthcare providers brought before it on appeal. It shall have the power to study and report the appellant's compliance with all the requirements of appeal, review the grounds of appeal, and provide reports and recommendations to the Board *en banc*. With the concurrence and approval of the majority of all its members, the CAAC shall elevate its written report and draft decision to the Board *en banc* for the latter's consideration and approval.

V. OTHER ACCOMPLISHMENTS OF CAAC

In line with the Corporation's steadfast commitment to excellence and the national goal of achieving universal health care in the Philippines, the Technical Working Group (TWG) was tasked to review and amend provisions on, among others, the qualifications and procedures for claims appeals, penalties resulting in suspension of accreditation, and the reinstatement of

penalized Health Care Providers. The TWG convened in a series of meetings, the dates of which are as follows:

No. 10606 (National Health Insurance Act of 2013), and R.A. No. 11223 (Universal Health Care Act).”** This is scheduled for public consultation in the first quarter of CY 2026.
