CY 2022 Performance Report of the Committee on Appealed Administrative Cases

Approved by the Committee on Appealed Administrative Cases on 20 January 2023

Under the Revised Implementing Rules and Regulations of the National Health Insurance Act of 2012 (R.A. No. 7875, as amended by R.A. Nos. 9241 and 10606), the Committee on Appealed Administrative Cases ("CAAC" or the "Committee")¹ is mandated to study and review the decisions on administrative cases against health care providers before it on appeal.

In 2022, the CAAC was composed of the following Members: Secretary of Health, Secretary of Labor and Employment, Secretary of Social Welfare and Development, PhilHealth President and CEO, three (3) expert panels, a representative of the Employers Group Sector, and a representative of the Direct Contributors Sector.

The CAAC had reviewed 1,506 counts of administrative cases against erring health care institutions and professionals for violations of R.A. No. 7875, as amended by R.A. Nos. 9241 and 10606, and its Implementing Rules and Regulations, broken down as follows:

- a. 1476 counts of Breach of the Warranties of Accreditation/Performance Commitment;
- b. 20 counts of Misrepresentation by Furnishing False or Incorrect Information; and
- c. 10 counts of Filing of Multiple Claims.

Upon undergoing judicious and meticulous evaluation of the merits of the appeals/motions for reconsideration, the CAAC elevated its recommendation to the PhilHealth Board, then the Board, through the corresponding PhilHealth Board Resolutions ("PBRs"), decided on the recommendations of the Committee.

The CAAC likewise discussed the following policy-related matters:

- 1. 2016 Quasi-Judicial Provisions of the RIRR of R.A. No. 10606;
- 2. PBR No. 2334, s. 2017 and Corporate Order No. 2018-0039; and
- 3. Request for Attorney positions needed by the Legal Sector, Arbitration Office, and the Office of the Corporate Secretary.

¹ It shall have the power to study and report the appellant's compliance with all the requirements of appeal, review the grounds of appeal, and provide reports and recommendations to the Board en banc. With the concurrence and approval of the majority of all its members, the CAAC shall elevate its written report and draft decision to the Board en banc for the latter's consideration and approval.
