# CY 2024 Performance Report of the Governance Committee Approved by the Governance Committee on 19 March 2025

#### I. INTRODUCTION

The PhilHealth Board benefits from the active participation of various subcommittees dedicated to safeguarding members' interests, shaping management policies, guiding critical business decisions, and ensuring effective governance. These subcommittees play a vital role in supporting the Corporation's mission to serve every Filipino. Among these essential groups is the Governance Committee (GovCom), committed to assisting the Board in fulfilling its corporate governance responsibilities. Ultimately, the Governance Committee fosters alignment across all subcommittees through the participation of their chairpersons as the governing body. This committee contributes significantly by:

- 1. **Guiding Board Performance:** The GovCom regularly evaluates the performance of the Board and its committees, promoting continuous improvement and effectiveness.
- 2. **Developing Policies and Procedures:** The GovCom proactively develops and recommends policies, procedures, and standards for the Board's consideration and approval, ensuring robust governance practices.
- 3. **Shaping Program Development:** The GovCom plays a key role in reviewing and recommending priorities for the development of impactful programs and application systems, enhancing service delivery.
- 4. **Contributing to Board Initiatives:** The GovCom undertakes additional responsibilities as assigned by the Board, demonstrating its adaptability and commitment to supporting the organization's needs.

#### II. OVERVIEW

The Governance Committee has proactively addressed key initiatives and provided valuable recommendations to the Board throughout the year. Starting with its initial meeting on February 15, 2024, the Committee has made significant progress on several fronts. The Committee also played a crucial role in shaping PhilHealth's future by finalizing the PhilHealth Corporate Strategy Map and CY 2025 priorities in the third quarter. This work effectively operationalized the strategic framework for the development of the comprehensive 2024-2030 PhilHealth Strategic Plan. To ensure adequate staffing, the Committee endorsed the hiring and re-hiring of additional Job Order Contractors (JOCs) for CY 2024 and CY 2025. Transparency and accountability were also prioritized with the endorsement of the PhilHealth Executive Session Guidelines and the CY 2023 Governance Committee Accomplishment Report for Board approval and publication.

Throughout the year, the Committee championed several important organizational advancements. They recommended Board approval for the forward-looking PhilHealth Research and Branding Project (PhilHealth Brand Refresh), aimed at enhancing PhilHealth's image and reach. A thorough review and benchmarking of the proposed Revised Delegation and Signing Authority (DSA) Policy, comparing it with other GOCCs, led to its successful approval resulting in streamlining of operations. Also, a key achievement was the approval to recommend engagement with the Department of Public Works and Highways (DPWH) for the construction of the PhilHealth Corporate Center. This included authorizing PCEO Emmanuel R. Ledesma, Jr. to execute the Memorandum of Agreement and empowering the DPWH as the implementing agency, ensuring adherence to the highest building standards. The Committee also

recommended Board approval for the design development of a new building in PRO XII, further demonstrating PhilHealth's commitment to infrastructure development.

Finally, the Committee demonstrated responsiveness to organizational needs by granting an extension for the PhilHealth Casuals position program design, ensuring the corporation maintains its necessary staffing levels.

### III. COMMITTEE MEMBERS

The Governance Committee benefits from the guidance and expertise of seven accomplished panels representing diverse perspectives from across government and related sectors. These expert panels, carefully selected for their deep understanding of corporate governance and commitment to PhilHealth's success, work collaboratively to ensure the corporation's effective operation.
