CY 2021 Performance Report of the PhilHealth Board's Governance Committee

The PhilHealth Board's Governance Committee (GovCom) is mandated to assist the Board in fulfilling its corporate governance responsibilities. Its functions and duties have also been expanded under PhilHealth Board Resolution (PBR) No. 2402, s. 2018 which resolved to approve the merger of the Nomination Committee and the Executive Committee with the Governance Committee. For CY 2021, the GovCom convened three (3) times and approved/discussed the following:

- I. Review and Recommendation of Executive/Managerial Positions, as part of its Nominations Committee functions, to wit:
 - 1. Senior Vice President, SG 28 for Legal Services Sector
 - 2. Department Manager III, SG 26 for FFIED
 - 3. Department Manager III, SG 26 for CorPlan
 - 4. Department Manager III, SG 26 for Comptrollership Department
 - 5. Department Manager III, SG 26 for PRID
 - 6. Department Manager III, SG 26 for Accreditation Department
 - 7. Department Manager III, SG 26 for BDRD
 - 8. Assistant Vice President, SG 26 for PRO II
 - 9. Assistant Vice President, SG 26 for PRO XII
 - 10. Assistant Vice President, SG 26 for PRO IV-A
 - 11. Assistant Vice President, SG 26 for PRO BARMM
 - 12. Assistant Vice President, SG 26 for PRO VIII
- II. Review of the Revised PhilHealth Manual of Corporate Governance, with the following objectives:
 - 1. To align the Manual with the Universal Health Care (UHC) Act and clarify the delineations of the responsibilities of Management vis-à-vis the policy-making and quasi-judicial functions of the Board.
 - 2. To incorporate updated guidelines per current GCG Memoranda, PhilHealth Board resolutions, etc.
- III. Proposed Organizational Structure of the Actuarial Services and Risk Management Sector (ASRMS). This is in compliance with the Insurance Commission audit findings and directive of the Secretary of Finance to augment the actuarial staff by October 1, 2021. The proposal increases the human resource complement of the sector from 12 to 35 positions, and creates 3 new offices, viz:
 - 1. Actuarial Investment Studies (8 new positions)
 - 2. Product Viability (8 new positions)
 - 3. Valuation and Liabilities (8 new positions)

The matter is currently being reviewed by the Civil Service Commission (CSC).

IV. Recommendation of Corporate-Wide Use of Digital Certificates. This is consistent with the Anti-Red Tape Authority (ARTA) Advisory No. 01 series of 2020 which mandates government agencies to adopt fast-track measures — including the use of electronic signatures — to ensure continuity of public services during this time of pandemic. These efforts also complement the intent behind Republic Act No. 11469 or the "Bayanihan to Heal as One Act" to promote efficiency among the public sector.

The Board agreed to consider using digital signatures.
