To All Organized Groups (OGs) and Individually Paying members (IPMs) under the iGroup (formerly KaSAPI) Program, PhilHealth Regional Offices (PROs)/Local Health Insurance Offices (LHIOs) and All Health Care Providers (HCPs)

All Individually Paying Members (IPMs) registered through the new iGroup Program are hereby advised of the processes involving availment of the expanded out-patient benefit called the Primary Care Benefit 1 (PCB1) Package initially available to the Sponsored Program, Overseas Workers Program and all IPMs under an iGroup Partnership of the National Health Insurance Program. Along with this privilege is the opportunity to avail of benefits immediately upon the effective date of the Group Policy Contract Validity.

1. Institutional HCPs (hospitals, health centers/ rural health centers and other accredited health care facilities) should be guided on the enhanced Member Data Record (MDR) unique to the iGroup Program as shown below:
