1st AND 2nd QUARTER 2016 PER FAMILY PAYMENT REIMBURSEMENT (PFPR) FOR PCB1 PROVIDERS WITH SLOW AND/OR NO INTERNET CONNECTIVITY

All manual reports covering 1st and 2nd quarter 2016 submitted by PCB1 providers who are experiencing slow and/ or no internet connectivity as verified by the PRO-IT shall be processed, following the guidelines stated in PhilHealth Circular No. 0010, s. 2012.

In addition, the concerned PCB1 provider shall be required to submit a transmittal list of the 1^{st} and 2^{nd} quarter enlisted and profiled members and dependents in Excel Format (see template below). The transmittal list must be submitted on or before the end of the 3^{rd} quarter otherwise, their PFPR for the 3^{rd} and 4^{th} quarter shall not be processed.

For the 3rd and 4th quarter 2016, all concerned PCB1 providers shall be required to submit their reports through any of the certified EMR provider, hence, manual reports submitted for these quarters shall no longer be processed.

All PCB1 Providers already using the U-PCM or EMR are advised to continue encoding the enlistment and profiling of members and dependents as stated in PhilHealth Circular No. 2016-0013. All encoded data are currently being tracked for payment.
