



UPDATED PHILHEALTH PREMIUM PAYMENT SLIP (PPPS)

By virtue of PhilHealth Circulars 2017-003 and 2017-0004, the PhilHealth Premium Payment Slip (PPPS), which is used for payment of premium contributions to our Accredited Collecting Agents (ACAs), now includes entries for members enrolled as Filipinos with Dual Citizenship, foreign retirees registered with the Philippine Retirement Authority (PRA) and other foreign citizens working and/or residing in the Philippines.
