

# Call for PhilHealth GAMOT Providers

With the launch of PhilHealth GAMOT or Guaranteed and Accessible Medications for Outpatient Treatment (PhilHealth Circular No. 2025-0013), all FDA-licensed retail pharmacies are advised to become accredited as PhilHealth GAMOT providers.

Pharmacies may submit accreditation requirements to the respective PhilHealth Regional Office (PRO) of their area. Please find the requirements for accreditation are attached on this advisory. You may also access them through the following links:
