PHILHEALTH CIRCULAR

No. 030 - 2015

TO : ALL PHILHEALTH MEMBERS, ACCREDITED HEALTH CARE PROVIDERS (HCPs), PHILHEALTH REGIONAL OFFICES (PROs), AND ALL OTHERS CONCERNED

SUBJECT : NEW ICD 10 CODES AND CATEGORY TITLES RELATED TO CHRONIC KIDNEY DISEASE

I. RATIONALE

In accordance with PhilHealth Circular No. 24-2015: New PhilHealth Dialysis Package (Revision 1) and the DOH Department Circular No. 2014-0417 adapting the Philippine ICD 10 Modifications (Second Edition, May 2014), the new ICD 10 codes/category titles herein are given the appropriate assignment.

II. SCOPE

V. EFFECTIVITY

This Circular shall take effect 15 days after publication. It shall be published in any newspaper of general circulation and shall be deposited thereafter with the National Administrative Register at the University of the Philippines Law Center.
