The Rules was drafted with the intention of ensuring prompt and speedy disposition of administrative cases to ensure universal access to NHIP benefits of members and other stakeholders.

The 5th National PhilHealth Legal Forum has reinforced the commitment of the participants and encouraged them to enhance their skills and legal knowledge as there were known Resource Speakers invited to give lectures on important topics which directly relate to the functions of lawyers in the Corporation. More significant is the message of the Keynote Speaker, Dean Raul C. Pangalangan of UP College of Law, who was one of the nominees to the JBC for the selection and screening for Chief Justice of the Supreme Court. To capsulize his speech, I would put it in this thought "PhilHealth is advancing social justice, as we aim for universal coverage". The corporation may become the most vital instrument of the government in promoting social justice and alleviating the conditions of the poor communities in the country.
