A total of 1000 members have participated in the PhilHealth Stakeholders' Summit organized by PhilHealth Regional Office (PRO) IVA held at the De La Salle Animo Center, Dasmariñas City last June 3, 2023. The activity is a 2-in-1 event consisting of the National Summit and the PhilHealth Konsulta Registration, simultaneously held in key sites across the country.

The event was made possible through the initiative of PRO IVA led by Regional Vice President Dr. Danilo M. Reynes in partnership with the City Government of Dasmariñas led by Mayor Jennifer Barzaga. The event was attended by different sectors which includes company locators from the First Cavite Industrial Estate (FCIE), Persons

with Disability PWDs, Solo Parents, Senior Citizens, Green Ladies, KDBM, 4Ps Parent Leaders, LGU Dasmariñas employees and the DepEd Schools Division Office of Dasmariñas, and Cavite-based local media. Registered PhilHealth Konsulta members had their First Patient Encounter with participating accredited PhilHealth Konsulta Providers.

PhilHealth Konsulta covers primary care consultations, health screening and assessment, selected laboratory or diagnostic services and medicines as prescribed by the physician.

To date, a total of 177 Konsulta providers have been accredited by PRO IVA in the Provinces of Quezon, Laguna and Cavite, with a combined 1,566,692 members have been registered to the Konsulta providers of their choice. ###
