TERMS AND CONDITIONS:

- 1. Suppliers shall provide correct and accurate information required in this form.
- 2. Suppliers shall quote on the project.
- 3. Price quotation/s must be valid for **thirty** (30) calendar days from the date of submission.
- 4. Price quotation/s, to be denominated in Philippine Peso shall include all taxes, duties and/or levies payable.
- 5. Quotation exceeding the Approved Budget for the Contract of the item shall be rejected.
- 6. Award of contract shall be made to the lowest quotation (for goods and infrastructure), passed the technical evaluation or, the highest rated offer (for consulting services) which complies with the minimum technical specifications and other terms and conditions stated herein.
- 7. Any interlineations, erasures or overwriting shall be valid only if they are signed or initialed by you or any of your duly authorized representative/s.
- 8. The item/s shall be delivered according to the requirements specified in the Technical Specifications and the official address of the corporation.
- 9. PhilHealth shall have the right to inspect and/or to test the goods to confirm their conformity to the technical specifications.
- 10. In case two (2) or more suppliers are determined to have submitted the Lowest Calculated Quotation/Lowest Calculated and Responsive Quotation, PhilHealth shall adopt and employ "draw lots" as the tie-breaking method to finally determine the single winning provider in accordance with the GPPB Circular 06-2005.
- 11. Payment shall be made via check (Land Bank) after delivery and upon the submission of the required supporting documents, inspection and acceptance.
- 12. Liquidated damages equivalent to one-tenth of one percent (0.1%) of the value of the goods not delivered within the prescribed delivery period shall be imposed per day of delay. PhilHealth shall rescind the contract once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount, without prejudice to the other courses of action and remedies open to it.
- 13. Warranty Security of one percent (1%) of the gross amount (for items with warranty) shall be automatically deducted from the contract for a minimum warranty period of three (3) months for expendable goods or one (1) year warranty for non-expendable goods and shall be returned after the lapse of the warranty period provided however that the goods delivered are free from defects and all the conditions imposed under the contract have been fully met.
- 14. The contracting parties shall comply with Office Order No. 0018-2015 "Reiteration of PhilHealth No Gift Policy (Revision 1).
- 15. Each of the documents submitted in satisfaction of the requirements is an authentic copy of the original, complete, and all statements and information provided therein are true and correct.

TECHNICAL SPECIFICATIONS

PREVENTIVE MAINTENANCE OF CORPORATE MOTOR VEHICLE (Repair & Maintenance Services of Air-conditioning System & Replacement of Worn-out Parts of One (1) PHIC Corporate Vehicle Isuzu Crosswind SAB-4464)

I. Coverage

The service provider shall provide all parts, personnel, tools, supervision and other items for the repair of the corporate vehicle.

The technical specifications on the specific scope of work shall include the following:

- 1. General Cleaning of Air-conditioning system which include leak tests & flushing of system.
- 2. Pull down of evaporator and condenser for general cleaning.
- 3. Replacement of worn-out parts as follows:
 - a. Replace expansion valve front & rear
 - b. Replace drier
 - c. Replace cooling coil front original
 - d. Replace cooling coil rear original
 - e. Replacement of O-ring
- 4. Other works which includes:
 - a. Add capillaoil and vacuum
 - b. Recharging of Freon gas
 - c. Re-condition of Compressor

II. Responsibility of the Service Provider

- 1. Ensure that the motor vehicle is secured and properly handled upon turn over by the end-user.
- 2. Ensure that the material, parts and components are brand new, original, genuine and compatible with the typology of the motor vehicle.
- 3. Comply with the provisions and perform necessary works stated in this technical specification.
- 4. Conduct the necessary testing and inspection procedures to ensure quality workmanship and completed works.
- 5. Surrender all defective parts, components and relative miscellaneous items to the end—user for proper accounting and disposal.

6. Ensure that all supporting documents (e.g., vehicle checklists, service orders, inspection reports, etc.) are submitted to the end-user once available for proper documentation.

7. Allow the end-user to inspect the works being performed to the motor vehicle during

the implementation of the project.

8. Waive any additional storage fees and/or charges prior to the release of the motor

vehicle to the end-user.

9. Rectify immediately and accordingly and damage, malfunction, or defects caused to any parts, components, and system of the motor vehicle outside this technical specifications due to negligence and/or mishandling at no additional cost to PhilHealth.

III. Delivery Period

Delivery period shall be within Thirty (30) calendar days upon receipt of the vehicle and conforme of the approved contract.

IV. Terms of Payment

Payment shall be within Ten (10) working days upon submission of Billing Statement of Service Invoice and Certificate of Acceptance.

V. Warranty

The service provider shall ensure a three (3) month warranty from the date of final inspection and acceptance and shall be responsible for repairs and parts which should fall under the warranty.
