The PhilHealth Regional Office VII now invites bids for the **Procurement of Various Furniture and Fixtures**. Delivery of the Goods is required one hundred twenty (120) calendar days upon receipt of Notice to Proceed. Bidders should have completed within two years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information from PhilHealth Regional Office VII and inspect the Bidding Documents at the address given below during office hours (8:00AM - 5:00PM).

A complete set of Bidding Documents may be acquired by interested bidders on the schedule of activities as stated below and upon payment of **P 5,000.00**

It may also be downloaded free of charge from the website of the PhilGeps and the website of the Procuring Entity, provided that bidders shall pay the applicable fee from the Bidding Documents not later than the submission of their bids.

The **PhilHealth Regional Office VII** reserves the right to accept or reject any Bid, to declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
