



RESOLUTION NO. 54, SERIES OF 2021

RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO COPYLANDIA OFFICE SYSTEMS CORPORATION FOR THE PROCUREMENT OF REPAIR AND MAINTENANCE OF RISOGRAPH PRINTING MACHINE DUPLICATOR, DEVELOP EZ 570 A FOR CY 2021

Whereas, Section 7.2 of the 2016 Revised Implementing Rules and Regulations (RIRR) of the Republic Act No. 9184 (R.A. 9184) otherwise known as the Government Procurement Reform Act provides that no procurement shall be undertaken unless it is in accordance with the approved Annual Procurement Plan (APP) of the procuring entity;

Whereas, based on the Project Procurement Management Plan (PPMP) and Annual Procurement Plan (APP) of Philhealth-CAR, the procurement of repair and maintenance of various office equipment shall be conducted through Direct Contracting;

Whereas, Section 50 (c) of the Revised IRR of the RA 9184 provides that Direct Contracting may be resorted to as a mode of procurement for goods sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the Government of the Philippines;

Whereas, Riso Kagaku Corporation issued a certification in favour of Copylandia Office Systems Corporation being its exclusive distributor in the Philippines for Riso Brand Machines, related accessories, consumables and spare parts;

Whereas, based on the supply source survey submitted by various suppliers (Copylandia, Laser Marketind and Xworks Sales & Services Inc), the repair and maintenance of Photocopier: Develop Ineo 163 cannot be availed of since the model has already been declared to have End of Life or EOL;

Whereas, based on the same survey, only Copylandia Office Systems Corporation can provide the repair and maintenance of Risograph Printing Machine Duplicator, Develop EZ 570 Λ ;

Whereas, a Matrix of Canvass/Market Study was prepared to determine the ABC for the repair and maintenance of Risograph Printing Machine Duplicator, Develop EZ 570 Λ ;

Whereas, after determining the ABC in the amount of Thirty Two Thousand Nine Hundred Fifty Seven Pesos (P 32, 957.00), a Request for Quotation was issued to Copylandia Office Systems Corporation for the procurement of Risograph Printing Machine Duplicator, Develop EZ 570 Λ ;

Whereas, Copylandia Office Systems Corporation submitted its quotation for the repair and maintenance of Risograph Printing Machine Duplicator, Develop EZ 570 A at a cost of Thirty Two Thousand Nine Hundred Fifty Seven Pesos (P 32, 957.00) which is within the ABC;

CONTRACT FOR THE REPAIR AND MAINTENANCE OF THE RISOGRAPH PRINTING MACHINE DUPLICATOR, DEVELOP EZ 570 A

THIS AGREEMENT made and entered into this _____ day of August 2021, in the City of Baguio, by and between:

PHILIPPINE HEALTH INSURANCE CORPORATION, a government owned and controlled corporation duly created by virtue of R.A. 7875, as amended by R.A 9241 and R.A. No. 10606 or the "National Health Insurance Act of 2013", with regional office address at SNOBT, Inc. Building, No. 19 Leonard Wood Road, Baguio City, represented herein by its Acting Regional Vice President, DOMINGA A. GADGAD, MD, MPA, PhilHealth Regional Office - CAR (hereinafter called "PHILHEALTH");

-and-

COPYLANDIA OFFICE SYSTEMS CORPORATION, with business address at Ground Floor Paladin Hotel, 136 Abanao Extension Corner, Cariño Street, Baguio City represented herein by its Branch Manager, **LAURENTE T. MUÑOZ** (hereinafter called **COPYLANDIA**).

WHEREAS, the procurement for the repair and maintenance of the Risograph Printing Machine Duplicator, Develop EZ 570 A through Direct Contracting is in accordance with the 2021 Annual Procurement Plan (APP) of PHILHEALTH;

WHEREAS, COPYLANDIA is the exclusive distributor in the Philippines for RISO Brand Machines, Develop Branded black and white, and color electrostatic plain paper copying/printing machines and their consumables and spare parts in the Philippines;

WHEREAS, PHILHEALTH requested COPYLANDIA to submit a price quotation on the project "Procurement of Repair and Maintenance of Risograph Printing Machine Duplicator, Develop EZ 570 A" and PHILHEALTH accepted the quotation in the amount of Thirty Two Thousand Nine Hundred Fifty Seven Pesos (P 32,957.00) hereinafter called "the Contract Price":

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Price Quotation of COPYLANDIA
 - b. Scope of Work
 - c. Notice of Award





- In consideration of the payments to be made by PHILHEALTH to COPYLANDIA as 3. hereinafter mentioned, COPYLANDIA hereby covenants with PHILHEALTH to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract;
- 4. PHILHEALTH hereby covenants to pay COPYLANDIA in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract;
- 5. The Contract Price covers the costs of all Deliverable Items and Services and includes all applicable taxes, including the 12% Value Added Tax (VAT), customs duties, license fees, freight, insurance, cost of importation and delivery at the time and locations specified and other charges which may be imposed on the Product by foreign and local authorities;
- COPYLANDIA hereby covenants to deliver in favor of PHILHEALTH the goods subject 6. of the project "Procurement of Repair and Maintenance of Risograph Printing Machine Duplicator, Develop EZ 570 A" and the services related thereto, in accordance with the Scope of Work as stated in attached Annex A of this Contract;
- 7. After complete delivery to and acceptance by PHILHEALTH, COPYLANDIA shall submit the STATEMENT OF BILLING ACCOUNT and other documentary requirements as may be required by the former as condition for payment. PHILHEALTH shall thereafter pay the ninety nine percent (99%) of the total amount of the required items and services as scheduled in the Scope of Work;

As obligation for the warranty, PHILHEALTH shall withhold one percent (1%) of the total contract price as retention money or as obligation for "Warranty" in an amount equivalent to THREE HUNDRED TWENTY NINE PESOS AND FIFTY SEVEN CENTAVOS (PhP 329.57) only or a special bank guarantee equivalent to at least one percent (1%) of the total contract price. The said amount shall only be released after the lapse of the warranty period or in the case of Expendable Supplies, after consumption thereof, as required under Section 62 (Warranty) of the Revised IRR of R.A. 9184. Provided, however, that the goods supplied are free from patent and latent defects and all the conditions imposed under this Contract have been fully met.

- The unit price quoted by COPYLANDIA shall be valid until December 31, 2021. 8. PHILHEALTH shall, in case of additional job order, pay the amount payable computed based on the price quotations.
- 9. The contracting parties undertake to comply with Office Order No. 0018-2015 entitled "Reiteration of PhilHealth No Gift Policy Revision (1)" which is deemed incorporated into this contract. Specifically stated, "No PhilHealth personnel shall solicit, demand, or accept, directly or indirectly, any gift from any person, group, association, or juridical entity, whether from the public or private sector, at anytime, on or off the work premises where such gift is given in the course of official duties or in connection with any transaction which may affect the functions of their office or influence the actions of directors or employees, or create the appearance of a conflict of interest";





- 10. The parties and any or all of their staff or representatives who will be involved in this project shall be required to sign a mutual Non- Disclosure Agreement and maintain strict confidentiality on any information accessed from the PhilHealth database or provided by PhilHealth. This condition shall apply even after the contract ends. The contracting party shall not disclose any proprietary or any confidential information relating to PhilHealth or to this agreement without prior written consent from the latter.
- 11. If any dispute or difference of any kind whatsoever shall arise between the parties in connection with the implementation of the contract covered by the Act and this IRR, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation, otherwise the same shall be submitted to arbitration in the Philippines according to the provisions of Republic Act No. 876, otherwise known as the "Arbitration Law" and Republic Act No. 9285, otherwise known as the "Alternative Dispute Resolution Act of 2004"
- 12. All other terms, conditions and stipulations accompanying this Contract together with all proposals and all mandatory provisions of the Revised Implementing Rules and Regulations of R.A. 9184, shall form an integral part of the contract between the PARTIES hereto;

The PARTIES hereby certify that they have read or caused to be read to them each and every provision of the foregoing Contract and that they had fully understood the same.
