The PhilHealth Regional Office IV-B, through the Corporate Operating Budget for CY2021 intends to apply the sum of One Million Six Hundred Ninety Three Thousand One Hundred Forty Five Pesos(P1,693,145.00) being the ABC to payments under the contract for Negotiated Procurement of IT Supplies of PRO IV-B, Lot 1 and Lot 2 under IB No. PRO4B-21-12. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The *PhilHealth Regional Office IV-B* through the *Corporate Operating Budget for CY2021* intends to apply the sum of One Million Four Hundred Eighty Thousand Eight Hundred Pesos (P1,480,800.00) for Lot1 and Two Hundred Twelve Thousand Three Hundred Forty Five Pesos (P212,345.00) for Lot2 being the ABC to payments under the contract for each lot/*item*. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The PhilHealth Regional Office IV-B now invites bids for the above Procurement Project. Delivery of the Goods is required by not more than thirty (30) calendar days after the effective date of the Contract or Notice to Proceed.
